

ADM School Board elections will take place November 2, 2021. The ADM School Board is comprised of five members, each of whom represent the citizens of our communities. Two seats are up for election in November to fulfill four-year terms. 
#### November 2 Vote: Physical Plant and Equipment Levy (PPEL) and Revenue Purpose Statement (RPS)

On November 2, ADM residents will see two ballot questions pertaining to ADM Schools. One question will ask voters if they approve a voted Physical Plant and Equipment Levy of \$1.34 per \$1,000 of property tax for a period of 10 years. Another question will ask voters if they approve an updated Revenue Purpose Statement (RPS) to authorize expenditures from revenue received from the state of lowa Secure an Advanced Vision for Education (SAVE) Fund. # A Focus on Learning and Results

Starting with the 2021-22 school year, all students in grades PK-9 are administered the FAST screening assessment(s) in the areas of math and reading. The screening assessments are given three times each year. The purpose of each screening assessment is to identify students who are not yet meeting grade level proficiency in the areas of reading and math. Teachers use the data from each screening assessment to identify students who need targeted interventions and support for acquisition of specific skills.

Using the data from the screening assessments and other diagnostic assessments, teachers work with students to provide evidence-based interventions and instruction that targets specific foundational skills that students may be missing in math or reading. Students who receive this additional support are monitored weekly to identify if the intervention is working and if the student is improving in the identified area of need. Below are ADM's Fall FAST Reading scores.

# **ADM's Wildly Important Goal**

Decrease PK-11 grade students identified as "not yet proficient" in reading on the identified grade level state assessment from 24.6% to 15% by June 1, 2022.

## **Open Enrollment**

On Monday, October 11, the ADM Board of Education approved a resolution to allow open enrollment in grades K-8 for the 2022-23 school year. Open enrollment remains closed for grades 9-12 due to insufficient classroom space factors and for special education students due to current case loads of special education teachers.
