- I. Introductory Procedures
  - 1. Meeting was called to order at 2:36 p.m. by Dr. Gomez.
  - 2. Establishment of Quorum: Quorum was established with 6 out of 10 with 1 parent, 3 teachers, and 1 other staff. The following members were present: Rosa Gomez, Erika Cruz, Gina Maharaj, Melony Morales, Gabriela Renata Sosu and Imelda Lemon
  - 3. Pledge of Allegiance was recited.
  - 4. Members were introduced, welcomed and asked to sign in.
- II. Action Items
  - 1. There weren't any revisions noted in the February 4, 2021 minutes:
    - a. It was motioned by Mrs. Maharaj/seconded by Mrs. Cruz/carried by all (Maharaj/Cruz 6/0/0) to approve the minutes as revised.
  - 2. Approve Categorical Expenditures Requests (TI, LCFF-LI, LCFF-EL)
    - a. Proposed categorical expenditures on the categorical expenditure request sheet were reviewed and discussed.
      - o Dr. Gomez stated that the digital screens fro classrooms were to replace Smartboards that were no longer going to be serviced.
    - b. It was motioned by Mrs. Cruz/seconded by Mrs. Maharaj/carried by all (Cruz/Maharaj 6/0/0) to approve all Title 1/LCFF-LI/LCFF-EL expenditures as listed on the expenditure request sheet.
  - 3. Approve Title 1 School Compact
    - c. Dr. Gomez reviewed revisions to the school compact. It was reviewed and discussed.
      - Mrs. Maharaj suggested to add to the compact under the parent responsibilities section. The first bullet point read, "Follow the traffic laws." It was recommended to add "...and appropriate entrances/exits during arrival and dismissal." This was added as precautionary measures to ensure safety.
    - d. It was motioned by Mrs. Maharaj/seconded by Mrs. Cruz /carried by all (Maharaj/Cruz 6/0/0) to approve the school compact.

    - e. Dr. Gomez reviewed revisions to the Title 1 Site Parent Involvement Policy. It was reviewed and discussed.
