Classroom Interventions and Responses

Examples of Classroom Instructional & Behavioral Interventions and Responses

These interventions aim to teach correct and alternative behavior so students can learn and demonstrate safe and respectful behaviors. Teachers are encouraged to try a variety of teaching and classroom management strategies in addition to the ones suggested below.

- Chunked lessons and engaging instruction
- Use of Technology to check for understanding
- AVID Strategies
- Use of a planner or interactive notebook
- Greeting Students at the Door
- Starting class with a fun get to know you or community building activity
- Blackboard Connect
- Reminders & Redirection
- Contact parent/guardian, conferences
- Teacher-student conference
- Written Reflections/apologies
- Classroom Incentive System, Eagle Points
- Seat Change
- Varied Seating Arrangements
- Loss of Classroom Privileges
- Personal Conversation after live session
- College & Career Guidance Initiative (CCGI) lessons

Site Interventions

Examples of PBIS, and or Discipline Team Interventions & Responses

These interventions will involve support staff, including counselors, administrators, intervention specialists, academy coordinators/student advisers, to engage the student's support system to ensure successful learning and consistency of interventions and change the conditions that contribute to the student's inappropriate or disruptive behavior.

- Whole Group Grade Level Meetings (administration)
- Monthly lunchtime graduation/college workshops (admin)
- Quarterly Classroom Visits (counselors, admin)
- Tutoring Services - Eagle Scholar Center
- College & Career Center Services & Guest Speakers
- Parent Conferences
- PBIS School Wide System of Incentives
- Monthly Parent Workshops (admin, POSSE)
- Grade Level Parent Workshops (administration)
- Transcript Evaluations (counselors)

Level 2

Examples of Intensive Support Staff & Administrative Interventions

These interventions can involve the school administration and aim to correct behavior by stressing the seriousness of the behavior while keeping the student in school.

- **SST** (counselors, teachers, administration, intervention specialists)
- **SART** (counselors, administration, academy coordinators/student advisers, intervention specialists)
- **Saturday School** (administration)
- **Back on Track Grade Level Conferences** (administration)
- **Wiley Center Referral**
- **College Excursion/s** for identified students (administration)
- **Peer Mediation** (admin)
- **Parent/Student Conferences** (administration, counselors)
- **Mentor Program** (5 x 5 type) for students that need add'l support
- **Check in/Check Out (CICO)** (administration)
- **Weekly Home Visits** (SRO, admin)
- **Graduation Checks** Grades 11 & 12 (counselors)
- **Monthly Grade checks** (academies, AVID, counselors)
- **Academy Student Contract/Behavior Plan** (mandatory tutoring)
- **Transcript checks** (academies, AVID, college and career center)
- **Annual Recognition Events** (academies, AVID)
- **Student Shadowing**
- **Mandatory Tutoring**

"At Risk" – 3 or more F's, 3 + absences, & credit deficient, report is pulled every 5 weeks

Level 3

Examples of Other Referral Responses, Suspension, and Expulsion

These interventions may involve the placement of the student in a safe environment that provides additional structure to address behavior. They may also involve the short or long term removal of a student from the school environment because of the severity of the behavior. Removing a student from the school community should be a last resort. The duration of any removal from classroom or school, if issued, is to be limited as much as practicable while adequately addressing the behavior. Interventions focus on maintaining the safety of the school community and ending self-destructive or dangerous behavior.

- Parent or guardian notification
- Community Conferencing/mediation
- Referral to substance abuse counseling
- Referral to community organizations, including community mediation
- Referral to outside credit recovery program
- Consultation with IEP and Special Education Team
- Revision to Functional Behavioral Assessments/Behavioral Intervention Plans
- Revision to IEP, 504 Plan
- School Based Counseling
- Modified class schedule
- SARB
- Short-term suspension: 1-5 days (last resort)
- Expulsion (last resort)
