 - \$2,743.32 LCFF-LI Budget Adjustment for increased substitute costs for previously approved teacher release days for collaboration and professional development
 - Dr. Bentley provided clarification that because the collaboration days were held; the increased costs will be paid by the site, either way. Ms. Milkie expressed disappointment that the District would not provide additional funding.

The response from the District was that students do have the ability to remain low and away from doors and windows in classroom spaces. Mr. Garnett expressed disagreement with the District's response. Dr. Bentley clarified that the school seeks to add the window coverings to reduce visibility and as a way to increase school spirit and school pride across campus. Dr. Bentley further clarified that the Library coverings were funded through

- other site funds, these funds would be used to provide additional window coverings in other areas on campus.
