BABYLON JUNIOR- SENIOR HIGH SCHOOL DRIVER EDUCATION PROGRAM

SPRING 2022 SEMESTER

We are excited to announce that Babylon High School will be continuing its NYS Education Department certified Driver Education course for the fall semester. Upon successful completion of this course, students will receive an MV-285 (Student Certificate of Completion) which gives them the opportunity to obtain a Senior Driver's License at age 17 and an insurance reduction according to the policies of your insurance carrier. They will also receive an MV-278 (Pre-Licensing Course Completion Certificate) which enables the students to schedule a road test with the DMV.

Driver's Education is divided into two parts, classroom instruction (24 hours) and in-vehicle instruction (24 hours). The New York State Education Department and the Department of Motor Vehicles have provided schools with guidance that allows for flexibility in the way we administer our Driver's Education program.

LECTURE:

For sixteen weeks, an hour-and-a-half period of lecture <u>must</u> be attended by each student, along with an hour-and-a half of in-car instruction supervised by a parent/guardian. The program will begin Thursday, January 27th and end on Thursday, May 26th. All participants must be 16 years of age and in possession of their permit.

The cost of the course will be \$150.

Attendance is MANDATORY – The New York State Education Department and the Department of Motor Vehicle guidelines for Driver and Traffic Safety Education require a minimum of 24 hours of classroom instruction and 24 hours of in-car instruction in order to receive an MV-285.

Lecture classes with Mr. Morra will take place virtually on THURSDAY evenings from 7:30pm - 9:00pm via Teams.

DRIVING:

Due to COVID-19, we will not be contracting with a driving school to complete the in-vehicle instruction. Rather, as part of the program, students will complete the in-vehicle instruction, observation, and applied practice, under the direct supervision of their parent/guardian. The state is allowing for the 24 hours of in-vehicle instruction (6 hours of driving/18 hours of observation) to be completed under the supervision of a parent/guardian holding a valid NY State Driver's License. All parents/guardians will be given curriculum guidance and log sheets to indicate completion of driving lessons and observation time.

NOTE: Private lessons from Fitzgerald's Driving School (or any licensed driving school) can be used toward the 6 hours of parent/guardian driving time (documentation must be provided by the driving school).

Please submit the attached application and check in the amount of \$150.00 (made out to Babylon High School Driver Education) to Mrs. Michele in the Attendance Office.

<u>NOTE</u>: Prorated refunds for withdrawing students will be made during the first month of classes *only*. Under State guidelines, no credit can be given for this course.

Registration begins Tuesday, January 11th and ends Thursday, January 13th. Enrollment is limited.
