**SUPERINTENDENT’S REPORT**

Bethel Education Foundation, Dawnja Johnson

Bethel Education Foundation Executive Director Dawnja Johnson shared highlights of the Foundation’s accomplishments over the past year, which included funding classroom grants in the amount of \$24,413. Ms. Johnson also reported on changes to the Foundation goals to better meet student needs and are more meaningful to the District as a whole.
