SUPERINTENDENT'S REPORT

WHS Student Representative Report, Juanita Dominguez

Juanita reported that Willamette's Jazz Band qualified to compete at the State Jazz Championship, which will be held at Mt. Hood Community College on May 19th. Willamette's Culinary Team won the state Culinary Championship and will be traveling to compete at a national competition. Seven teachers and counselors recently participated in "A Day in the Life" where they attended classes as students to learn about the student experience at Willamette. Juniors are taking Smarter Balanced tests this week. *The Addams Family*, Willamette's spring musical, will be held May 10th, 11th, and 12th at 7:00 p.m.

Science Curriculum, Cody Gulewich and Brian Flick

Superintendent Parra introduced Director of Teaching and Learning Brian Flick and Willamette Teacher Cody Gulewich. Mr. Flick and Mr. Gulewich shared a video of teachers and students in science classrooms throughout the District demonstrating new science curriculum. Mr. Flick described how materials from science kits are being repurposed to support the new science curriculum and reported on science programming. Mr. Gulewich described the digital online science textbook used at the high school level.

Indian Education, Brian Flick and Tina Gutierez-Schmich

Superintendent Parra introduced Director of Teaching and Learning Brian Flick and Equity Director Tina Gutierez-Schmich. Mr. Flick and Ms. Gutierez-Schmich shared some of the history of Bethel's Indian Education Grant, Title VI, which is a federal entitlement program. Bethel's Indian Education parent committee identified goals for the program for the 2017-18 school year, which included increasing knowledge of cultural identity and awareness for students, increasing parent participation in the program, and professional development for a subset of teachers. During the 2017-18 school year three family engagement nights were held and a mentor who is working with students at Willamette High School was hired. A group of students, parents, and District staff plan to attend the Oregon Indian Education Association conference in May. Mr. Flick and Ms. Gutierez-Schmich stated that the District is submitting an application for the Indian Education Grant for the 2018-19 school year and shared future goals of the program.

Print Shop II, Amy Tidwell, Remie Calalang, Patrick Sinnott, and Tricia Bradshaw

Superintendent Parra introduced Special Services Director Amy Tidwell, Human Resources Director Remie Calalang, Teacher Patrick Sinnott, and Printer Assistant Tricia Bradshaw. Ms. Calalang shared a photo of the District's new high volume digital printer located in Print Shop II, which is located at Willamette High School. Mr. Sinnott described how $9^{th} - 12^{th}$ grade students in his Bethel Transition Network classroom are gaining employment skills, technical skills, confidence, and pride by working with Ms. Bradshaw at Print Shop II.

Open Enrollment Update, Pat McGillivray

Community Relations Director Pat McGillivray provided an overview of Open Enrollment (OE) and shared the number of OE transfer requests to each building within the District for the 2018-19 school year.

Financial Statement, Simon Levear

Business Services Director Simon Levear reviewed the March 2018 financial statement showing an estimated Ending Fund Balance of \$5,921,296. Mr. Levear reminded the Board of information distributed at a previous meeting regarding fund balance goals and discussed PERS rate increases with the Board.

Legislative & School Finance Update

Superintendent Parra presented two articles; one from *The New York Times* titled "Pension: Why States and Cities Are Short on Cash;" and the other titled "Study: PERS better funded than most, but still short." Superintended Parra shared that she and Director Farr recently attended a meeting as part of a collaborative COSA work group focused on social/emotional well-being with a goal of developing policy to better meet the needs of students who are unable to regulate their behavior. ODE has a similar stakeholder group and it is anticipated that the two groups will merge.
