SUPERINTENDENT'S REPORT

Legislative & School Finance Update

Superintendent Parra reviewed draft components of Oregon Department of Education's *Ready Schools, Safe Learners Resiliency Framework for the 2021-22 School Year* which was released June 25, 2021. The updated guidance from Oregon Department of Education (ODE) focuses on advisory health and safety recommendations to mitigate the spread of COVID-19 and for students to return to full-time, in-person instruction for the 2021-22 school year. The final 2021-22 guidance from ODE is expected to be released by July 22, 2021. In addition, Superintendent Parra reported that ODE will be reviewing graduation requirements and has waived the essential skills requirement for students who graduate in 2021-22.

Instructional Hours Review

Superintendent Parra reviewed instructional hours for the 2021-22 school year and explained that hours at elementary grade levels in all buildings have been aligned.
