

NON-RESIDENT TUITION CONTRACT

AGREEMENT made this \_\_\_ day of \_\_\_\_\_, between Mr. & Mrs. \_\_\_\_\_ ("Parents"), residing at \_\_\_\_\_ and the Bridgehampton Union Free School District, 2685 Montauk Highway, Bridgehampton, New York 11932 ("District").

WHEREAS, the Parents are non-residents of the District and desire to enroll their child(ren) in schools of the District; and

WHEREAS, the District agrees to accept the child(ren) into the schools of the District subject of the following conditions.

IT IS HEREBY AGREED, as follows:

1. The District agrees to accept for enrollment into the schools of the District the following child(ren):

2. The child(ren) shall be admitted to the District's schools as non-residents for the \_\_\_-\_\_\_ school year.

3. The Parents agree to pay the District tuition of \$\_\_\_\_\_ per year for the \_\_\_\_\_ school year. The Parents agree to submit payment to the District in accordance with either payment option A, payment option B, or payment option C, as set forth below. *Payments may be made by credit or debit cards using the district website at www.bridgehampton.k12.nv.us.*

Payment Options:

A. Full payment of the annual tuition for the \_\_\_-\_\_\_ school year. This payment must be received by the District upon execution of this Agreement by all parties; or

- B. Payment of the annual tuition for the \_\_-\_\_ school year shall be made in two (2) equal installments of \$\_\_\_\_\_. The first installment must be received by the District upon execution of this Agreement by all Parties; the second installment must be received on or before February 1<sup>st</sup>; or
- C. Payment of the annual tuition for the \_\_-\_\_ school year in ten (10) monthly installments, beginning on September \_\_, \_\_\_\_ and continuing monthly thereafter on the first of each month. Such monthly payment shall equal \$ \_\_\_\_\_.

4. Should there be any outstanding balances due from a previous semester a student will not be admitted to a new semester. Should the District not receive payment in accordance with either option A, B or C, the District may, at its sole discretion, exclude the child[ren] from the schools of the District upon at least 24 hour notice to the parents. The District may, at its sole discretion, extend any time period relating to payment due dates as set forth above.

5. The annual tuition charge shall be prorated for the period of time the child[ren] attend school in the District.

6. Enrollment may continue for the applicable term provided payments are made consistent with this Agreement and as long as the child[ren] abide by school rules, demonstrate good citizenship, achieve academic success, and provided the child[ren]’s participation is otherwise satisfactory to District officials.

7. In the event any child[ren] who has been admitted to the District pursuant to this Agreement seeks or requires a change in placement, the child[ren] shall only be permitted to continue to attend the schools of the District if the District determines that there is sufficient space in an appropriate educational program of the District for such child[ren].
