- 4. Should there be any outstanding balances due from a previous semester a student will not be admitted to a new semester. Should the District not receive payment in accordance with either option A, B or C, the District may, at its sole discretion, exclude the child[ren] from the schools of the District upon at least 24 hour notice to the parents. The District may, at its sole discretion, extend any time period relating to payment due dates as set forth above.
- 5. The annual tuition charge shall be prorated for the period of time the child[ren] attend school in the District.
- 6. Enrollment may continue for the applicable term provided payments are made consistent with this Agreement and as long as the child[ren] abide by school rules, demonstrate good citizenship, achieve academic success, and provided the child[ren]'s participation is otherwise satisfactory to District officials.
- 7. In the event any child[ren] who has been admitted to the District pursuant to this Agreement seeks or requires a change in placement, the child[ren] shall only be permitted to continue to attend the schools of the District if the District determines that there is sufficient space in an appropriate educational program of the District for such child[ren].
