1. Shall the annual budget of the Bridgehampton Union Free School District for the fiscal year 2010-2011 in the amount of \$9,951,049.00 be approved and the requisite portion thereof be raised by taxation on the taxable property of the School District?

2. Shall the amount of \$125,000 be raised by taxation to be expended on behalf of the Bridgehampton Child Care & Recreational Center pursuant to a contract for child care services for the 2010-2011 school year?

3. (a) Shall the Board of Education of the Bridgehampton Union Free School District, in the County of Suffolk, New York (the "District"), be authorized to construct various improvements to the Bridgehampton School and the site thereof; and to expend therefor an amount not to exceed the estimated total cost of \$1,350,000; (b) that a tax is hereby voted in the amount of not to exceed \$1,350,000, and a further tax is hereby voted to pay the interest on said bonds as the same shall become due and payable; such taxes to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; and (c) that the District expects to receive certain aid from the State of New York, and all of such aid, as and when received by the District, shall be applied to offset and reduce the taxes hereby authorized.

Shall the Board of Education of the Bridgehampton Union Free School District (the "District") align the District's policy with the existing District practice of providing bus transportation for all resident students who attend Grades Kindergarten through 12 up to a maximum distance of 15 miles, effective for the 2010-2011 school year and thereafter, and to appropriate a maximum estimated sum in the amount of Sixty-Two Thousand (\$62,000) Dollars during the District's fiscal year of 2010-2011 and to levy the necessary tax therefor?
