The 2010-11 Proposed Budget Budget, Board of Education Election and Propositions

BUDGET

The budget proposition would authorize the appropriation of \$62,313,304 to meet estimated school district expenditures for the 2010-11 school year. *Approval of the budget would result in an estimated 1.4% increase in the tax rate.*

BOARD OF EDUCATION ELECTION

Voters will elect two members to the Board of Education. There are three candidates, whose names will appear on the ballot in the following order: Andrea Costanza, Linda Eckel Mendelson and Morton Stein. Voters may also write in names.

PROPOSITION #1

Capital Reserve Fund (General) Withdrawal

This proposition would authorize the withdrawal of \$1,428,000 for capital projects to include: roof replacement at Brookside, lighting upgrade at Council Rock Primary School, parking lot lighting replacement at Council Rock Primary School, and a district-wide building condition survey. *Approval of this proposition would not increase the proposed budget or tax rate.*

PROPOSITION #2

Capital Reserve Fund (Technology) Withdrawal

This proposition would authorize the transfer of \$400,000 from the Capital Reserve Fund (Technology) to the District's General Operating Fund and to expend this sum from the District's General Operating Fund for computer-related equipment and software in accordance with the purposes set forth in the authorizing resolution establishing this fund. *Approval of this proposition would not increase the proposed budget or tax rate*.





Proposed Budget Reductions 2010-11

In February 2010, the preliminary budget presentation included a proposed budget of \$62,933,295, a difference of \$2,385,950, a 3.9% increase over the 2009-2010 budget, and a 3.9% increase in the property tax levy. This proposal would maintain the same program and staffing levels as this year.

Since January, Dr. McGowan and Mr. Gary Valenti, Assistant Superintendent for Administration have been working with the Board and staff to reduce next year's preliminary projection of expenditures by reviewing every budget line. These efforts have resulted in proposed budget reductions totaling approximately \$770,000 plus new initiatives costing approximately \$150,000, which result in a net reduction of approximately \$620,000 from the preliminary 2010-11 budget or an increase of 2.9% over the current year's budget with a projected tax rate of 1.4%.



1999-2000 to 2009-10






Cost Per Pupil

True Value Tax Rate 2009-10 County Average \$22.64/thousand





Budget Information

Proposed Expenditures

Total Proposed Expenditures for 2010-11 are \$62,313,304 an increase of 2.9% over the 2009-10 budget.

- **\$ 4,428,526 General Support:** Among the many areas in this category are operations and maintenance, central printing, central media services, pupil services, and legal services. This category is down 2.7%. Utility costs are down \$100,000 due to the District's energy efficient efforts in a variety of areas.
- **BOCES:** The Board of Cooperative Educational Services (BOCES) is a cooperative arrangement to provide specialized services for 10 eastside school districts. This category is increased by \$192,360 or 3.3%. The number of students budgeted for Today's Students Tomorrow's Teachers is down 7 students. The budget reflects an increase in several ancillary services for students with disabilities. Mandarin is included in the proposed BOCES budget at a cost of \$16,000.
- **\$ 783,976 School Budgets:** This category includes individual school budgets for textbooks, library books, field trips, equipment, supplies, etc. This category represents an overall decrease of 11.5%.
- **Instructional and Support Personnel:** This category represents the major part of expenditures. It is up 2.2% and includes all staff salaries based on anticipated negotiated contracts with all of the district's bargaining units. Staff changes include consolidation of positions, eliminated positions, the equivalent of 2.5 new full-time positions to meet the needs of the students and district, plus \$150,000 for new initiatives.
- **Benefits:** This category is up by \$1,126,114 or 8.1%. This increase includes a \$755,600 increase with a budget of \$8,623,600 or a 9.6% budget to budget increase in health insurance. The \$158,000 increased cost of mandated employee retirement contributions will be paid out of the District's Employee Retirement Contribution Reserve Fund created last year in anticipation of this increase.
- **\$ 205,466 Interscholastic Sports:** This category is up by 4.6% and includes the interscholastic program for the high school and middle school.
- **Transportation:** This includes the cost of transporting students to Brighton public schools as well as over two dozen private and parochial schools. This category will increase \$28,261 or 1.2%, which includes a transportation contract increase based on the Consumer Price Index.
- \$ 2,381,388 Debt Service: This category represents a reduction in the debt service of \$26,691. Included in this is a reduction of \$25,000 due to eliminating an inter-fund transfer to the School Food Service Program. This category includes interest and principal payments on construction bonds from previous capital projects.



Projected Revenue

Brighton Central School District's revenue estimates include state aid based upon the Governor's proposed New York State budget, which results in an expected \$1.5 million dollar reduction in State Aid. The proposed State budget includes the second of two years of federal stabilization funds, which are included in our revenue estimates.

Three Part Budget Information

Program Component

The program component represents the largest portion of expenditures. This component maintains all current programs and services and supports the District's mission and vision. This component provides funding for instruction and educational support services for all students. Transportation, health services, library, co-curricular activities, and athletics are also included in this area.

The Capital Component includes costs associated with the operation and maintenance of the District facilities, including utilities, building and equipment repairs, and grounds maintenance. Funds are also included for principal and interest payments on capital projects.





Advanced Placement Results

Advanced Placement courses are offered in several academic areas including Biology, Calculus, Chemistry, Computer Science, Economics, English Language & Composition, English Literature & Composition, European History, Environmental Science, French, German, Physics, Political Science, Psychology, Russian, Spanish, Statistics, Studio Art, U.S. History, U.S. Government and Politics, World History, and Music Theory. Exams are graded on scores of 1 to 5; grades of 3 and above are generally accepted for college credit. In 2009, 438 students wrote 1,131 exams, with 83% of the exams receiving a score of 3 or better. In 2008, 433 students wrote 974 exams, with 83% of the exams receiving a score of 3 or better. In 2007, 439 students took 1013 exams, with 86% of the exams receiving a score of 3 or better. In 2006, 441 students wrote 1031 exams, with 82% of the exams receiving a score of 3 or better. In 2005, 432 students wrote 952 exams, 81% received 3 or better.

Dual Credit Programs

Students at BHS take dual credit courses through Monroe Community College and Syracuse University. Brighton provides the option for college level courses in lieu of or in addition to Advanced Placement courses. This year, 18 students took SUPA (Syracuse University Project Advance) Economics and 13 took SUPA Statistics. SUPA courses are taught by Brighton faculty members who are also Syracuse University Adjunct Instructors. In addition, several Brighton students are enrolled in a variety of dual credit courses through MCC including Calculus III, Leadership, Digital Photography, Digital Imaging, and Technical Graphics.

Educational Quality

National Merit Scholarship Program

The National Merit Scholarship Program is an academic competition for recognition and scholarships. To qualify students must take the Preliminary SAT/National Merit Scholarship Qualifying Test. Each year, more than a million students nationwide qualify for consideration based on an index score that includes critical reading, mathematics, and writing skills scores. Brighton High School's Class of 2010 with 288 students has 7 National Merit Scholarship Finalists, 7 National Merit Scholarship Semi-Finalists, 24 National Merit Scholarship Commended Students, and 2 National Achievement Semi-Finalists. In addition, several Brighton students are selected each year to receive special scholarships funded through various corporations through the National Merit Scholarship Corporation Program.





Brighton Pride

- Eighteen of our 349 teachers in the school district have earned National Board Certification, an advanced teaching
 credential. National Board Certification is the highest credential in the teaching profession. The National Board
 of Professional Teaching Standards awards certification to teachers who spend at least one year studying the effects of their teaching on student performance and documenting their subject area of knowledge. Approximately
 880 teachers in New York State hold this national certification.
- Several Brighton teachers and administrators have received State and national honors from the School Administrators Association of New York Region II, National Honor Roll Outstanding American Teachers, New York State English Council, New York State Public High School Athletic Association, Who's Who Among America's Teachers, and local honors from Rochester Philharmonic Musicians' Awards for Outstanding Music Educators, Nazareth College's Awards for Excellence in Business Education Award and Excellence in Literary Education, and Touching the Future Award from Hobart William Smith College. Several Brighton teachers have been selected to serve as Directors and Judges for a variety of local, regional, State and national organizations and related events.
- Brighton Central School District celebrates its diverse student population, including students representing 57 different countries of origin and speaking 27 diverse first languages.
- Over 1600 Brighton students participate in the grade 4 12 instrumental program, which includes multiple grade levels of band, orchestra, jazz ensembles, chamber groups, and instrumental lessons. Approximately 580 Brighton students participate in a variety of grade 4 12 choral ensembles and voice lessons.

Where is the Class of 2009?

- 94% of the students in the Class of 2009 planned to continue their education at 4 or 2-year colleges. Brighton students enrolled in more than 113 different post-secondary institutions
- Six percent of Brighton students had other plans including employment, military and travel.



Brighton Pride

- There are over 1600 student roster slots on our 86 interscholastic athletic teams, which include Modified, Freshmen, JV, and Varsity sports.
- There are 85 co-curricular clubs at Brighton High School, which approximately 90% of the students participate in. Approximately 90% of the students at Twelve Corners Middle School participate in its 35 clubs before and after school. Brighton students also have the opportunity to participate in a variety of academic competitions such as Science Olympiad, E-Cubed Fair, FBLA, Math League, DECA, Model UN, and Masterminds.
- All sixth grade students have the opportunity to participate in Outdoor Education, an extension of the 6th grade life science curriculum. For two days and one night, students participate in hands-on activities including ropes courses, orienteering, archery, outdoor cooking and fishing.
- Each year, Brighton students and staff participate in numerous community service projects for the benefit of others including clothing drives, food drives, cancer-related fundraisers, and the American Heart Association's Jump Rope-A-Thon, which has resulted in French Road Elementary School leading the nation in donations for the past eleven years.
- Brighton students of all ages have opportunities to participate in a variety of field trips, which enhance the curricula, such as the stream study at Mendon Ponds, and field trips to Ganondagan, Rochester Museum & Science Center, and the Genesee Country Village & Museum.

Cost Efficiencies Strategies

Efforts to Control Costs and Minimize Impact on Taxpayers

The District continues to explore ways to control costs and minimize the impact on taxpayers. Current cost containment measures used by the District include:

Cooperative Bidding

For the procurement of products and certain services that will exceed the maximum level allowed by law during the fiscal year

Employee Benefits

Self-insuring either cooperatively or individually for Workers' Compensation, dental insurance and health insurances Negotiating an increase in employee contribution

Going Green

Using mandated green cleaning products, expanding existing recycle program, reducing the amount of paper, installing an automatic shutoff to District computers, lowering pool and hot water temperatures, installation of energy-efficient windows and boilers, and replacing inefficient light fixtures

Partnerships and Grants

Self insuring cooperatively for liability and property insurance

Purchasing services and instructional, staff, and curriculum support services through BOCES

Collaborating with area colleges to provide a wide variety of learning opportunities

Renting out classroom space not currently needed

Receiving grants to enhance the educational program

Cooperatively purchasing natural gas, food and supplies

Partnering with the Town of Brighton to share resources and programs

Reserve Funds

Reserves are funded through year-end surplus, interest earned on reserve fund balances, and with State Aid received on prior year's expenditures from reserves.

The Brighton Central School District invested \$12 million in capital improvements over the past ten years through a Capital Reserve Fund. Capital Reserve Funds allow us to invest in our facilities on a yearly basis without having a large bond issue and incurring additional debt.

The Brighton Central School District invested \$4.8 million in technology over the past ten years through a Technology Reserve Fund. Technology Reserve Funds allow us to invest in information technology on a yearly basis without increasing the budget, property tax levy or incurring additional debt.

The proposed 2010-11 budget adjustments totaling \$1,765,959 is offset by an additional \$670,000 from Reserve Funds resulting in a projected increase in the tax rate of 1.4%.
