
# Important Update: Environmental Testing

ARIGHTON



- Brighton has conducted voluntary water testing on a periodic basis for many years.
- In December, administration discovered that we had some elevated levels of lead in the water in isolated locations throughout the District.
- Upon investigation, and in partnership with the State and County Departments of Health, we concluded it is not a source problem.
  - The issue commonly arises in devices that are older or infrequently used.



## What We Have Done

ARIGHTON

- In accordance with EPA regulations, a flushing protocol was instituted.
  - Flushing consists of running water through the device for a period of five minutes.
- Additional testing post-flush showed that flushing procedure reduced levels in all but 8 devices.
  - These were removed from service
- We have worked closely with our school doctors, Monroe County and NYS health departments and the Monroe County Water Authority to determine what had happened, what we should do about it, and the best steps moving forward.



# What We Are in the Process of Doing



- Any device that requires daily flushing will be labeled with a NOTICE sign.
- We will flush when needed and replace when post-flush testing does not show levels at an acceptable level.
- We will ensure staff and students have access to filtered water fill stations/fountains.
- The Board has engaged an environmental consultant to develop a comprehensive testing protocol and make recommendations to further mitigate any risks.
