

We are close to wrapping up another school year at the Brockport Central School District. Despite being in the homestretch, we continue to push our students to apply 100 percent effort through the end of school to ensure they are well prepared for their future.

Our strategic plan for continuous academic improvement includes a mission to "engage and empower each student to achieve excellence as a learner and citizen," along with a vision to "aspire to be a leading, innovative, high-performing school district."

In the three years since implementing these goals in the district, faculty and staff have found unique and innovative ways to educate and enrich students that connect with our core beliefs. Our BHS seniors recently celebrated "100 Days to Graduation" with a day of fun activities. This milestone marks their years of hard work toward their diploma and their future. Coming this far in their educational journey is a direct result of their "work ethic," another one of our core beliefs. We're so proud of our graduating class of 2019.

With all the security incidents surfacing in schools throughout the country, our core belief "safety" was the theme of our March Superintendent's Conference Day. Faculty and staff spent the day in safety and security related sessions, including talking with law enforcement about active shooter dangers. Sheriff Todd Baxter kicked off the day with a powerful keynote about safety within our schools and reminded faculty and staff "it's not paranoia... it's prevention." His presentation was an important reminder to all of us here at the Brockport Central School District to know what our plan is in case of an emergency.

Brockport teacher honored as 2019 Hall of Famer

Each of us has a teacher who has made difference in our life. Someone who believed in us or pushed us to succeed. Christopher Albrecht, a Hill School fourth-grade teacher, is an example of such an educator. Albrecht's dedication to his students and love of teaching led to his nomination and ensuing induction to The National Teachers Hall of Fame.

Albrecht has been a Hill School faculty member since 1998. Previously, he taught in West Virginia for three years, for a total of 23 years in K-12 classrooms.

Albrecht was nominated for this prestigious award by his friend and fellow NYS Teacher of the Year, Richard Ognibene. In his nomination letter, Ognibene wrote: "Chris is a remarkable teacher and human being. He represents all that is best about teaching and learning. I have seen him speak to thousands of teachers from a stage and read to dozens of kids from a classroom floor. In each case, I felt inspired."

A former student, Benjamin Olson who is now a US Marine Corps Sergeant, wrote: "There is a leadership principle in the Marine Corps—'Seek responsibility and take responsibility for your actions.' I learned this long ago in Mr. Albrecht's class. Even now, twelve years after leaving his class, he still keeps in touch with me through phone calls, emails and text messages. This past deployment, his entire class wrote letters back and forth to the Marines in my platoon. My years with Mr. Albrecht built the foundation of the man I am today."

The National Teachers Hall of Fame, located in Emporia, KS, will be inducting the Class of 2019 in June. Five recognized teachers will meet for a week of professional development and a celebration of teaching. Albrecht will meet his four other "classmates" in May when the National Education Association will honor them at a special meeting with the Executive Board at their headquarters in Washington DC. An appearance on National Public Radio and meetings with political and government officials will also take place.

BCSD assessments continue to climb

The are excited to announce that over a five-year period student assessments increased in both ELA and mathematics.

These annual ELA and math tests for students in grades 3-8 are required by the Federal Every Student Succeeds Act (ESSA) of 2015 and measure student learning. The tests also show how schools and districts are progressing with the New York State Learning Standards.

Summer Literacy Program

I is widely understood that on average students lose academic ground during the summer, a phenomenon frequently referred to as summer learning loss or summer slide. Understanding this, the Brockport Central School District is once again excited to announce the Summer Literacy Program. Students in grades K-6, receiving Academic Intervention Services, will be given the opportunity to attend this program between July 15 -August 8, 2019 at the Fred Hill Elementary School. And...no Fridays!

Students and teachers love this program! Teachers participate in professional development two days per week and are able to collaborate with colleagues as they focus on increasing their pedagogical expertise. Students get to engage as learners in a small group setting where they participate in the Readers and Writers Workshop.

Pioneered by Lucy Calkins and her TCRWP colleagues and refined over decades of research and piloting with thousands of teachers, reading and writing workshops are deliberately designed to offer a simple and predictable environment. Teachers can focus on the complex work of observing students' progress and teaching into their needs.

- Each session begins with a mini-lesson where kids sit with a long-term partner.
- The mini-session ends with the kids doing their own independent work.
- As students work, the teacher confers with them and leads small groups.
- During independent work time the teacher stands and delivers a mid-workshop teaching point.
- The workshop ends with a share.

In addition, students receive 30 minutes of word work/skill block where they focus on basic foundational skills such as grammar, spelling, phonics and language conventions. Resource guides have been created by the Office of Instruction designed to ensure the growth of students and provide a strong core instructional program.


The end result...51% of Brockport students not only eliminated the summer slide but increased their rate of proficiency as identified by the iReady diagnostic this fall! More information on the program is forthcoming. We look forward to working with your child this summer!

Capital improvement

This summer while the students are away crews will be hard at work redesigning the Brockport Central School District campus. Crews have already started the new tennis courts, which are part of phase two of the capital project.

The majority of work in the capital project was included in the 2015 District Building Condition Survey/Capital Facilities Five-Year Plan and/or the 2016 New York State Energy Research and Development Authority (NYSERDA) FlexTech Study. The project was approved by voters in 2017.

The cost of the project is \$19,873,000 with 86.3 percent of the funding coming from New York State and the remainder \$3,300,000 coming from the Capital Reserve Fund.



The project focuses primarily on safety and security improvements including secure entryways in each school. The project also focuses on enhancing energy efficiency. Expense types are broken into three categories: building, construction, site construction and incidentals. Incidentals include professional services and other expenses not considered direct construction such as architect and engineering, construction management, legal, financial, testing and inspection, asbestos monitoring, printing, insurance and financing costs, and NYS fees.

Work is expected to be completed in phases through the fall of 2019.



Building and site repairs include:

- Secure vestibules at all schools
- New tennis courts
- New parking lots and sidewalks
- Roof work
- Floor tile replacement
- Energy improvements
- BHS lavatory renovations

What parents need to know about vaping

Substance abuse trends are taking on a whole new life with e-cigs, otherwise known as vaping. According to the National Institute on Drug Abuse, the devices are "fairly easy" or "very easy" to get with more than 1 in 10 eighth-graders admitting to vaping nicotine in the past year.



While many perceive vaping as better or healthier than smoking that isn't the case. According to the American Lung Association, using electronic cigarettes or vaping, particularly the flavored varieties, can cause popcorn lung. Studies show vaping destroys the protective cells in a person's lungs, triggering lung inflammation and tissue damage - often associated with the development of COPD.

Many vaping devices are very small and inconspicuous, masking as pens or even flash drives. E-cig devices also don't leave any scent or smell making them hard to detect. The liquid inside could even be more than just nicotine. Among California high school students who have used an electronic smoking device, 27 percent said they used it with some form of cannabis, according to a 2016 report.

Signs your child is vaping:

- **Increased thirst.** Vaping dehydrates the skin and throat, resulting in increased thirst.
- **Nosebleeds.** Just like drying the mouth, vaping dries out the nose and can lead to nosebleeds.
- Finding unfamiliar USB drives, battery chargers or spare parts. E-cigs come in the form of unfamiliar tech-looking devices. Some also have parts that need to be replaced including wires, cotton balls or small containers containing e-juice.



Spotting cyberbullying

Unlike when moms and dads went to school, kids and teens have to deal with bullying that never lets up. Cyberbullying, a form of online bullying, has become a serious problem among teens. By being more aware of cyberbullying, teens and adults can help fight it.

Cyberbullying involves using technology, like cell phones and the internet, to bully or harass another person. Many cyberbullies believe bullying others online is funny or a joke and may not realize the consequences. Cyberbullying can be very damaging to the mental wellbeing of kids and teens and can lead to anxiety, depression, and even suicide.

Cyberbullying can take many forms:

- Sending mean messages or threats to a person's email account or cell phone
- Spreading rumors online or through texts
- Posting hurtful or threatening messages on social networking sites or web pages
- Pretending to be someone else online to hurt another person
- Sexting, or circulating sexually suggestive pictures or messages about a person

Families should create an open dialogue with their kids about the impact of their child's digital footprint and the potential ramifications with employers, colleges and law enforcement.

To qualify for the SupportMusic Merit Award, BCS answered detailed questions about funding, graduation requirements, music class participation, instruction time, facilities and support for the music-making programs. Responses were verified with school officials and reviewed by The Music Research Institute at the University of Kansas.

This award recognizes that BCS is leading the way with learning opportunities as outlined in the Every Student Succeeds Act (ESSA). ESSA recommends music and the arts as important elements of a well-rounded education for all children. We are fortunate to have such dedicated staff and an outstanding music program.

School HIGHLIGHTS

BHS Science Olympiad team qualifies for state tournament

For the first time in school history, a team comprised of 15 Brockport High School students qualified for the NYS Science Olympiad Tournament held at Lemoyne College. The team placed fourth overall out of 29 teams in the Science Olympiad Regional Championship held at The College at Brockport in February. Additionally, BHS students medaled in eight out of 24 events, meaning they placed within the top six, and several students finished in the top 10.

Science Olympiad challenges students in science, technology, engineering and mathematics (STEM) through team-based competitions and hands-on and written testing. This year, students designed and constructed mousetrap vehicles, boomilevers, rube-Goldberg machines, proteins, musical instruments, cooling devices, rubber band powered airplanes and a working hydrometer. Students also studied and prepared for tests and labs in various science fields, including glaciers, herpetology, genetics, thermodynamics, astronomy, chemistry, anatomy, epidemiology, technical writing, geology and environmental science.

Science Olympiad not only provides students the opportunity to immerse themselves in science education, but it also builds their excitement about life after high school.

The Olympiad team is coached by Joseph Flanagan, BHS biology teacher, and Marc Palmer, BHS technology teacher. "We are so proud of how hard these students prepared for these events. It's great to see them so excited about STEM and putting what they've learned to good use," said Flanagan. "Our hope is that the skills and knowledge they learn from these events will help them prepare for successful STEM careers in the future. The future looks pretty bright for these kids!"

Winning teams will advance to the national tournament held at Cornell University in June. Good luck BHS Olympiads!



Mock Newbery Club brings school districts together

Those successfully completing the class will receive an MV285 certificate that gives the holder the privilege to receive a Class D operator's license when reaching age 17, allowing them to drive after 9 p.m. Students must be 16 years old by July 8, 2019 and hold a valid NYS Driver Permit or License to be eligible for the course. The Pre-Licensing 5-hour Course material is included in Driver Education.

Most insurance companies will offer a discount on compulsory car insurance upon request.

2019-20 PROPOSED BUDGET

Dear District Residents,

The Brockport Central School District Board of Education adopted the proposed 2019-2020 budget during its April 9 meeting.

Each year, the Board of Education, administrators, teachers and staff collaborate to analyze data and assess needs relative to the school budget. The proposed \$82,496,416 budget for the 2019-20 school year aligns with the district's strategic plan for continuous academic improvement, that graduates each student prepared for their next step whether college or a career.

The following items are on the ballot for May 21:

• Proposition 1: 2019-20 Proposed Budget

This \$82,496,416 budget projects an estimated 1.56 percent tax rate increase (the actual tax rate is set in August). The budget was balanced utilizing \$3,492,219 of fund balance/reserves and a tax levy increase of 3.35 percent.

• Proposition 2: Bus Purchase Proposition

This proposition includes purchasing 12 buses and trading in 15 buses. The state aid ratio is approximately 87 percent, making the net local share per bus \$12,201. The estimated average cost for the bus proposition is \$3.05 per year on a house valued at \$100,000.

• Board of Trustee Election

Two Board of Education trustees will be elected to serve a five-year term beginning July 1, 2019. The terms of Terry Ann Carbone, Board President, and Kathleen Robertson, Board Trustee, will expire June 30, 2019. Candidates will run for two seats. Please see page VII for further information regarding candidates.

We encourage you to review the information on the following pages to learn more about the budget, propositions and board candidates. Community members will have an opportunity to learn more about the budget at a public hearing on Tuesday, May 7, 2019 at 7 p.m. in the Hill School Cafetorium. Additionally, the PTSA is hosting a Meet the Board Candidates Night on Wednesday, May 8, 2019 at 7 p.m. in the Oliver Middle School LGI.


Three Part Budget Summary of Expenditures

New York State law requires that school districts present the proposed budget in three parts: administrative, educational program and capital.

Administrative Component – includes expenses for the Board of Education, central administration, instructional supervision, curriculum development, legal services, central data processing, printing, mailing, storage, and employee benefits attributable to salaries included in these functions. The administrative component increased 1.87 percent. Some of the increase includes the following: Central Services: \$50,000 for legal fees; Employee Benefits across all portions of the administrative budget.

Educational Program Component – includes expenditures for instructional programs, school library/ audiovisual, attendance, counseling, health services, interscholastic athletics, student transportation, transfers to special aid fund, and employee benefits attributable to salaries included in these functions. The educational component increased 2.51 percent. Some of the increase includes the following: employee benefits across all portions of the educational program and over \$460,000 in BOCES special education costs.

Capital Component – includes expenses for operations and maintenance, grounds, security, utilities, principal and interest payments for debt service, transfers to capital fund, property tax refunds, and employee benefits attributable to salaries included in these functions. The capital component increased 4.97 percent. The significant change is found in the Principal/Interest Payments and Debt Service: There is a budgeted increase of over \$560,000 in debt service payments for the 2017 voter approved capital improvement project. This increase is support by additional state aid.

What is Brockport's allowable tax levy limit?

What is an "allowable tax levy limit?"

For school districts, the "tax levy limit" is the highest allowable tax levy (before exemptions) that a school district can propose as part of its annual budget for which only the approval of a simple majority of voters (more than 50 percent) is required. Any proposed tax levy amount above this limit will require budget approval by a supermajority (60 percent or more) of voters. Essentially, the "tax levy limit" sets a threshold requiring districts to obtain a higher level of community support for a proposed tax levy above a certain amount.


However, the new legislation does not place a limit on any taxes a school district would levy to pay for expenditures related to specific "exempt" items, including some court orders, some pension costs and local capital expenditures. These items are then added to the "tax levy limit" to arrive at the "allowable" tax levy limit.

The major sources of projected revenue for the 2019-20 school year are shown in the graph. State aid accounts for 51.32 percent of revenues. The local share, which represents local property taxes and STAR, accounts for 39.57 percent of revenues. District income, which represents all other sources of revenue, accounts for 9.11 percent of revenues.

Statement of assumptions made in projecting a contingency budget, pursuant to section 2023 of the Education Law, for the 2019-20 school year, should the proposed budget be defeated.

If the school district budget is defeated twice, state law requires a Board of Education to adopt a contingency budget. A contingency budget includes only those expenditures allowed under New York State regulations. Expenditures such as certain new and replacement equipment, salary increases for certain employees and student supplies would be eliminated. There would also be mandated charges for use of school facilities by outside organizations.


Final tax rates are established in August, when the tax rolls are prepared. These figures are only projections and are subject to adjustments. Projections are based upon the latest assessed values provided by the individual town assessors, and equalization rates established by the New York State Office of Real Property Tax Services.

School Bus Proposition

The district will have a proposition to purchase replacement school buses on the May 21 ballot in an amount not to exceed \$1,135,000. The proposition includes purchasing 12 buses and trading in 15 buses. If approved, the district will purchase seven large buses and five small buses. With the purchase of buses annually, the district will continue to have a fleet of nearly 100 buses on an eight to ten-year replacement schedule.

Brockport receives approximately 87.1 percent state transportation aid on school bus purchases. This means the district will receive \$988,585 in aid with the remaining \$146,415 local share being financed over five years (\$29,283 each year). The impact of \$29,283 on the levy is approximately \$0.03 per thousand of assessed value or \$3.05/year on a \$100,000 home.
