SUPERINTENDENT'S REPORT

Willamette High School Culinary Team

Willamette High School Principal Dan Hedberg introduced Willamette's 2019-20 ProStart Culinary Team members Makayla, Samantha, Antonio, Payton, and Charlise, and Teachers Martha Humphreys and PK Bunker. The students distributed a dessert they prepared to Board members and described the starter, entrée, and dessert they will be preparing at the upcoming state culinary competition. Students shared their experiences as part of the ProStart Culinary Team and Ms. Humphreys described the national competition, which was held in Washington, DC, that last year's ProStart Culinary Team participated in. Ms. Humphreys, Mr. Bunker, and the students answered questions from the Board.

WHS Student Representative Report, Elizabeth Ortiz

Elizabeth shared that 31 students from Willamette recently attended a Town Hall Symposium and approximately 200 tickets were sold for the winter formal sock hop, which students enjoyed. Elizabeth also reported on Willamette's Chess Team, a recent Wolverine Pageant fundraiser, a Pleasant Hill dodgeball competition that Wolverine Pageant contestants participated in, 8th grade tours, and 8th Grade Orientation, which will be held February 25th. A Winter Choir Concert will be held Wednesday, February 26th. Senator Wyden recently visited Willamette and met with students and teachers from the Sources of Strength class to discuss mental health and basic needs of the community. An assembly was recently held where students were recognized for academic and attendance achievements, as well as club participation. Tickets will go on sale soon for the Wolverine Pageant, which will be held Saturday, March 7th. Doors will open at 6:00 p.m.

GED students are completing internships at Prairie Mountain School, Evergreen Senior Living, and Lane County Parks. Seniors are finishing their internships and will have completed at least 16-20 volunteer service hours by the end of this week.

Budget Committee Interview and Appointment, Position 7

Chair Jorgensen welcomed Alisa Hammond and thanked her for her interest in the Budget Committee. Ms. Hammond was provided a copy of the 2020-21 Budget Committee Interview Questions document prior to the Board interviewing her for Budget Committee Position 7.

Director Cunningham shared that he has known Alisa Hammond and her family for many years and she is highly recommended for the Budget Committee.

2019-2021 Lane ESD Local Service Plan, Carlos Sequeira

Lane Education Service District (ESD) Board Member Erin Zygaitis summarized services provided by the 2019-2021 Lane ESD Local Service Plan – Year Two and thanked Director Cunningham for his commitment as a Lane ESD Budget Committee member. Lane ESD Executive Director Carlos Sequeira highlighted services that were added to the 2019-2021 Lane ESD Local Service Plan – Year Two, including a Librarian of Record and 1.0 FTE in technology dedicated to cyber security for Lane ESD's component districts.

Transfer Update, Pat McGillivray

Community Relations Director Pat McGillivray stated that it is a requirement for the Board to approve the number of students transferring into and out of the District each year, and referred to student transfer numbers for the 2020-2021 school year reflected in Resolution Nos. 19-20: 38 and 19-20: 39.

Legislative and School Finance Update

Superintendent Parra reported on Senator Wyden's visit to Willamette High School on February 18th where Senator Wyden engaged with students. Students were very supportive of the Sources of Strength program. Chair Jorgensen and Director Laisure were present during Senator Wyden's visit and shared positive feedback with the Board.

Superintendent Parra provided an overview of Oregon's March Economic Forecast.

Maintenance Supervisor Jason Betterley reviewed the District's Healthy and Safe Schools Plan (HASS Plan) requirements, which include monitoring for elevated levels of lead in water used for drinking or food preparation, lead paint, asbestos, radon, integrated pest management, and carbon monoxide detectors. The District's HASS Plan is required to be submitted to the state annually. Mr. Betterley and Superintendent Parra answered questions from the Board.
