In Community Eligibility Schools (CEP), applications are no longer collected. CEP eligibility is determined by the ISP on April 1 of the preceding school year and is elected in 4-year cycles. The number in this column reflects the ISP on April 1, 2022. To estimate the free and reduced rate for CEP schools, the ISP may be multiplied by 1.6 (the current USDA multiplier).
