Trustee Hindman moved to approve the use of \$295,000 from RDA payments to the district and \$118,308 of funds currently budgeted for deferred maintenance for the purpose of completing the Central Union High School English classroom, library classroom, kitchen and MPR and band room modernization; motion seconded by Trustee Jimenez.

Trustee Walker moved to approve the Addendum to the employment contract between the Central Union High School Board of Trustees and C. Thomas Budde, Superintendent; motion seconded by Trustee Hindman.

The following people addressed the board to express their concern and/or opposition to the proposed Addendum: Catherine Drew, ECSTA President, Diane Richmond, CSEA President, Bea Mora, CSEA, Neil MacGaffey, ECSTA.

INFORMATION ITEMS:

Dr. Budde reviewed the recommendations from Sodexo to reduce encroachment in the foods services department. He stated that the program continues to lose money providing breakfast and lunch to the students. Options to reduce the deficit include the elimination of 8-11 classified positions. Hal Yasa provided a power-point presentation detailing the potential changes and/or reductions he is proposing. Neil MacGaffey, ECSTA reported that making changes to the minimum Wednesday collaboration days would be an easy change. He encouraged the superintendent to talk to the foods service employees and explore all other options presented. Diane Richmond,

CSEA President also expressed concern and requested additional information be provided for the past six years. Trustee Vogel referred her to meet with the superintendent to obtain the information she wanted.

INFORMATION ITEMS: (continued)

Vincent Ruiz, head cook stated that food service employees had tried to meet with Mr. Yasa but that the meeting did not go well. Trustee Jimenez requested that Dr. Budde facilitate a meeting with all involved.

The monthly budget and cash flow report was provided.

SUPERINTENDENT'S REPORT:

Dr. Budde reviewed the current board policy and administrative regulation relating to students and transfer credits from a private school.

Mrs. Peggy Calvin addressed the board and express concern over the districts recent actions relating to students returning to the district after attending a private school. She stated that in some cases prior approval had been receiving from administration and then taken away after another administrator complained. The decisions appear to be arbitrary and the problem has not really been defined. She stated that she felt the board needed to know and become involve as it is a policy established by the board.

Mrs. Yvette Garcia read from a prepared statement detailing her experience with the same issue and her daughter. She suggested that the board review the existing policy and clarify for the benefit of the students.

Mrs. Isabel Cansedo also expressed concern and stated that credits her son earned the Spring of 2010 were also removed from his transcript. She reported that she had also met with a counselor and received prior approval.

The Board, by consensus gave the superintendent direction to reinstate credits with a P instead of letter grade for all student affected. The Board also requested that changes be made to the policy for clarification purposes and brought back for review.

Dr. Budde provided an update on the 2011 General Obligation Refunding Bonds process.

ECSTA AND CSEA COMMENTS:

Catherine Drew, ECSTA President reported on the status of the three (3) current grievances. She stated that two (2) of the grievances were in arbitration which could be very costly to the district. She reported that the Tentative Agreement had been voted down by association members and that the negotiating team would be going back to the table after a decision has been made regarding the Urie case.

Diane Richmond, CSEA President stated that she wanted to go on record in support of Josh Razmus. She reported that she hopes the meeting with the food service employees is a positive one and that maybe a different approach needs to be considered. She stated that a student survey might be helpful in reaching a decision as Mr. Yasa only met with some students. She again reiterated her concern over the post-employment retirement benefit being given to the superintendent in light of the current fiscal crisis.

Neil MacGaffey, ECSTA Vice President encouraged the board to look at the specifics regarding Mr. Razmus release from coaching duties. He stated that if it is a classroom issue, then every effort available should be made to provide assistance to the teacher.
