<u>PUBLIC HEARING TO DISCLOSE THE FISCAL IMPACTS OF THE TENTATIVE AGREEMENT MOU BETWEEN THE CUHSD</u> AND THE EL CENTRO SECONDARY TEACHERS' ASSOCIATION FOR THE 2012-2013 SCHOOL YEAR:

President Hindman declared a public hearing open for the purpose of disclosing the fiscal impacts of the Tentative Agreement MOU between the Central Union High School District and the El Centro Secondary Teachers' Association for the 2012-2013 School Year.

Catherine Drew, ECSTA President pointed out that listed in the warrant orders is a payment to CalStrs in the amount of \$96,719.62 which is the retirement buy-out for the superintendent. She expressed concern over the initial amount being disclosed to be "around \$80,000" and based on that number a "me too" bid was negotiated. She asked if that was not like unfair negotiating because all along the superintendent knew the number was going to be higher.

Trustee Jimenez questioned the "me too" clause in the MOU and requested clarification as he had a different understanding on the issue.

There being no comments, oral or written, President Hindman declared the public hearing closed.

ECSTA AND CSEA COMMENTS:

Catherine Drew, ECSTA President shared with the board a discussion Neil MacGaffey and herself had with the superintendent where he told them the "board" was in total agreement to get rid of the Agricultural Program at Southwest High School due to the arbitration amount that was awarded to Sam Urie. She inquired as to why Mr. Urie had not received the backpay owed him. She invited board members to contact her for further details. She reported that she and Neil plan to meet with each board member to discuss the survey. A couple of meetings with the superintendent have been held to discuss specifics of the survey. Trustee Walker reported that he had not yet received a copy of the survey. She inquired about attendance at the upcoming May 22 Budget workshop and whether ECSTA would be invited to attend.

Neil MacGaffey addressed the board and stated that while he appreciates the fact that no layoffs are proposed to address budget, the board needs to understand that is primary due to the class size MOU. He reported that strong discussions need to be held early on because ECSTA will not accept another class size MOU. Other options need to be explored for next year aside from the layoff of the counselors. He stated that he is hopeful the tax initiative will pass in November. He encouraged the board to review the budget in particular the healthy 27% reserve balance and the special reserve fund.

Diane Richmond, CSEA President reported that they are working on obtaining signatures in support of the November tax initiative and would appreciate support from the board.

SUPERINTENDENT'S REPORT:

Dr. Budde provided an update on the Central UHS modernization project. He reported that although they are behind schedule he anticipates the cafeteria being operational in early May. Training for staff has been scheduled. Work on the English building is progressing and should be ready in the Fall.
