Desert Oasis High School is located in El Centro, CA, a city with a population of approximately 44,364 (2017). Surrounding areas serviced by the Central Union High School District are Heber and Seeley which add approximately 1,000 students to the Central Union High School District attendance. Desert Oasis High School serves a transient population. Students may elect to attend DOHS for academic recovery, and there are those who have been sent through a disciplinary hearing panel. The student population fluctuates between 160-200 high risk students, grades 9-12, at any given period throughout the school year. The ultimate goals are to have students earn enough credits to return to one of the two comprehensive high schools in the district or to graduate from Desert Oasis within a year of their original graduation target.
