Many families already have utilized the option to take advantage no cost participation in ASB and sports participation this year. Students and parents were inundated with emails and communication from different sources (Remind, Skyward messenger, Google classroom, teachers, district, other parents, etc.). There was so much coming at them, many just stopped opening their messages. Our school does a good job providing many different places for students and parents to find this information (monthly newsletters, Skyward messenger, Remind, morning announcements and emails when school is in session, school orientation, etc.). During the last year families have learned a great deal about the importance of communication and what works best for them, so this should have a great impact going forward. People are also eager to participate in many of the areas that have been unavailable to them over the past year due to Covid restrictions. We'll have a better idea where we need to make adjustments in the Fall after we see how being back at school full time provides an impact to our numbers.
