Superintendent Report

Superintendent Moloney began her report by welcoming Madeline Scalici as the new student representative to the board along with student board rep alternate, Alyssa Howlett. She spoke on Student Achievement Initiative (SAI) Highlight and shared recently Chehalis School District being the recipient of STEM REVIT (Renewable Energy Vehicle Infrastructure Technician training grant in the amount of \$125,000. She shared the excitement with this grant in moving forward creating a curriculum and establishing a pathway at W.F. West focused on renewable energy careers. Back in June the board adopted Policy 2414 focusing on community service and the counselors at W.F. West have created a procedure to encourage and honor students we engage in community and school

service. The student with the most hours will earn the departmental award from the Counseling Center at the Senior Awards Assembly. She concluded her report congratulating Washington State School Psychologist of the Year, Melissa Chan.
