

Parent committees give permission to apply Lucy Zepeda moved to approve, Eric Schmidt seconded, and all approved the motion to apply for Consolidated application grant.
<p>New Business / Parent Information</p> <ul style="list-style-type: none"> ▪ Social-Emotional Supports for Students <ul style="list-style-type: none"> *Wellness Wheel *Positivity Project 	<ul style="list-style-type: none"> • Robyn Snyder introduced the wellness wheel to the committee and introduced Jon Logan and David Weber to the committee to discuss the wellness wheel in more detail. • Jon Logan gave a quick history of how the wellness wheel became part of the systems of Clovis Unified and emphasized the importance of having these supports built into our system. • David Weber added on more information and other opportunities including parent nights and community resources. • Laura Rameriz asked how parents can get more info about the parent nights and David Weber advised that it is communicated through email, Peachjar, and social media. • Jon Logan and David Weber then went through each of the spokes of the wellness wheel and what that looks like in our district. They also discussed the professional development that is offered to the CUSD staff. • Laura Rameriz asked how students are referred to BCT? Jon Logan explained the referral process for this particular support. • Eric Schmidt asked if the district positions are different than the All 4 Youth positions and David Weber explained the difference between the district employees and the community partners. • Eric Schmidt asked about how students get involved in peer mediation; David Weber explained the process for this. • Lisa Vuola then introduced the Positivity Project to the committee and showed a short introductory video to introduce the project. Lisa also provided examples of what P2 looks like at school sites and how schools apply it across grade levels.
