Lub Koom Haum ntawm Toxic Substances Control (DTSC) xav hais qhia rau lub zes zoj txog qhov hauj lwm yuav muaj tom ntej no rau daim av Fowler-McKinley Elementary School Project nyob ntawm lub ces kaum ntawm quam teb hnuv tuaj ntawm North Fowler Avenue thiab East McKinley Avenue hauv lub nroog Fresno, California 93727. Clovis Unified School District npaj siab yuav siv daim av no uas yog 22-acres los txua ib lub tsev kawm tshiab rau cov tub ntxhais kawm elementary. Lub tsev kawm ntawv tshiab no yuav muaj txog li 28 chav kawm kom haum 750 tus tub ntxhais kawm.

Nyob rau lub caij ntawm Lub 9 Hli Ntuj Xyoo 2018 thiab Lub 4 Hli Ntuj Xyoo 2019, kev tshawb nrhiav ib puag ncig ua tiav rau daim av no. Qhov kev tshawb nrhiav ib puag ncig pom tau hais tias daim av ntawm tej chaw muaj hlau (nrog rau cov tshuaj lom arsenic, hexavalent chromium, txhuas), total petroleum hydrocarbons (TPH, xwm li diesel thiab roj), thiab organochlorine pesticides (OCPs, nrog rau chlordane, dichloro-diphenyltrichloroethane (DDT), thiab toxaphene) saum toj rau theem av ua vaj tsev nyob. Qhov hauj lwm yuav muaj tom ntej no yuav los tu thaj av no los ntawm kev khawb thiab muab cov khoom pov tseg tawm ntawm thaj chaw. Cov av uas tsis huv yuav raug thauj mus thiab pov tseg ntawm qhov chaw tso cai thiab tsim nyog.

Kev ua haujlwm raug cia siab pib thaum pib lub Xya Hli 6, 2020 thiab vam tias yuav ua mus ntxiv li thaj tsam plaub lub lis piam; pej xeem yuav pom cov hauv qab no:

- Kev kwv yees kwv yees li 970 cubic yards ntawm cov av tsis huv thiab lub chaw khaws ib ntus ntawm cov av khawb;
- Kev tswj hwm huab cua thiab kev tiv thaiv plua plav yuav ua tiav thaum ua haujlwm hauv av;
- Kev kuaj pom zoo kom ntseeg tau tias txhua thaj av tsis huv raug tshem tawm mus ua kev ntxuav cov hom phiaj;
- Txhuam tag nrho cov log tsheb thiab sab nraud kom tshem av thiab khib nyiab ua ntej tawm ntawm Lub Xaib thiab cov tsheb thauj khoom yuav raug kuaj thiab npog ua ntej tawm ntawm Lub Xaib.
