- Career Technical Education, CTE programs (matching grants)
- Energy Related Projects (Solar, LED lighting, provide ongoing energy savings)
- Major Building Infrastructure Repairs (Roofing, HVAC, Plumbing, Electrical)
- Modernization at Sites (Improve, repair, architectural enhancements)
- Fine Arts Program Enhancements
- Support Services Projects
- Technology (Network improvements, AV systems, cabling)

FM3 Community Survey Data - \$408M vs \$311M
