4. 2012 Bond Measure Summary Report (HO)

Kyle Ellis reviewed the 2012 Bond Measure Summary Report with the committee and shared that \$1,448,689 is the unallocated balance currently not assigned to any projects. The 2016 projects are in progress, 2015 projects are ready to close out, and all highlighted numbers in orange indicates adjustments that have been made. Any project with funds available after closing will roll back into the allocated budget. Don pointed out approximately \$500,000 was left in the contingency allocated after the completion of the Boris Elementary project.

Don shared that a practice and tradition of Clovis Unified has been to spend some of the available funds to pay for the design of new projects for the next bond measure. Assuming if a bond measure passes in 2018 or 2020 the district will be ready to move forward with the construction process.
