<b>LOCATION</b>	<b>CLOVIS HIGH SCHOOL</b>
<b>IMPORTANT DATES</b>	<p><b>Independent Study Summer School</b> <b>BEGINS Tuesday, June 11, 2024 (First week is orientation week)</b> <b>ENDS Wednesday, July 24, 2024</b></p> <p><b>Session 1: June 11, 2024- July 3, 2024</b> <b>Session 2: July 9, 2024- July 24, 2024</b></p> <p><b>Class will not be held on Wednesday, June 19<sup>th</sup> ; students assigned to that days meetings will have their appointment rescheduled by the student’s teacher.</b></p> <p>All student work is to be completed and turned in to the student’s teacher by 5:00pm on Wednesday, July 24, 2024.</p> <p><b>Tuesday and Wednesday, June 11<sup>th</sup>, and June 12<sup>th</sup></b> Each teacher will schedule a one-hour orientation/enrollment on Tuesday or Wednesday. Any student who fails to meet their teacher on one of the orientation/enrollment days will not be guaranteed admission into Independent Study Summer School.</p>
<b>CLASS APPOINTMENTS</b>	<p>8:00 a.m. – 5:00 p.m., Tuesday or Wednesday Scheduled weekly appointments: 1-Hour Minimum.</p>
<b>NOTIFICATION</b>	<p>Students should be contacted by their Independent Study Teacher close to the end of the school year. If the IS Teacher has not made contact by June 6<sup>th</sup>, please call the Independent Study Office. The Independent Study Summer School phone numbers will be posted on school/district websites.</p>
<b>CREDIT RECOVERY ELIGIBILITY</b>	<p>To be eligible to enroll in credit recovery, a student <b>must be an enrolled CUSD student and</b> meet one of the following two criteria:</p> <ul style="list-style-type: none"><li>▪ Must be an incoming student in grades 10 – 12 that <b><u>must repeat a course</u></b> due to D or F or</li><li>▪ Must be deficient in credits/required courses for graduation</li></ul>
<b>ORIGINAL CREDIT ELIGIBILITY</b>	<p>Any student who needs an Original Credit course due to employment, an impacted school schedule, or special circumstance.</p> <ul style="list-style-type: none"><li>▪ Must attend a comprehensive school site.</li><li>▪ See Counselor who will determine if student meets criteria for Original Credit.</li></ul>

	<p>For a student to take an Original Credit course in Summer School, the student must meet the following three criteria:</p> <ul style="list-style-type: none"> <li>▪ Have an impacted schedule for the following school year <b><u>and</u></b></li> <li>▪ Possess a 3.0 or higher Semester GPA (unless otherwise indicated for exceptional circumstances) <b><u>and</u></b></li> <li>▪ Possess self-discipline, self-motivation, and be able to work independently</li> </ul>
<b>POSSIBLE CREDITS</b>	9 <sup>th</sup> , 10 <sup>th</sup> , and 11 <sup>th</sup> grade students may take up to 10 credits (1 full year course or 2 semester courses).
<b>ATTENDANCE</b>	<p>Students may miss only one appointment no matter the reason or emergency.</p> <p>Should a student miss a second appointment, he or she will be dropped.  <b><u>NO EXCEPTIONS WILL BE MADE!</u></b></p>
<b>STUDENT CONDUCT AND DRESS CODE</b>	<p><b>All Clovis Unified School District rules will be enforced during Summer School including CUSD Dress Code:</b></p> <p><b>Conduct:</b> Students are required to abide by the school code of conduct. Students who break the California Education Code are eligible for suspension. If a student is suspended, and the resulting effect is that they miss too many classes as defined by the summer school attendance policy, they will be dropped after serving their suspension.</p> <p><i>Zero tolerance offenses will be referred for further disciplinary action.</i></p> <p><b>Dress Code:</b> Students are required to comply with the district-wide dress code when attending course appointments. Students out of dress code will be sent home and marked absent.</p>
<b>AGREEMENT FORM</b>	<p>To be enrolled in Independent Study Summer School, the parent/guardian and student must sign a <b>SUMMER SCHOOL AGREEMENT <u>NO LATER THAN JUNE 19<sup>th</sup></u></b>.</p> <p>Students will receive the Agreement Form at the first appointment.  <b>Any student who does not have a parent's signature by their second appointment will be dropped from Independent Study Summer School.</b></p>
<b>TRANSCRIPT</b>	<p><b>Drop Procedures with no credits earned:</b></p> <ul style="list-style-type: none"> <li>● Drop before the end of the 1<sup>st</sup> week: Not recorded on HS Transcript</li> <li>● Drops after 1st week: Recorded as a NG (No Grade) on HS Transcript</li> </ul> <p><b>Once a course is completed, grades and credits will be posted on the students' transcript.</b>  <b><u>Summer School grade postings are permanent and may not be deleted.</u></b>  <b>Summer School courses may be repeated at the school site <u>ONLY</u> if the grade earned was a D or F.</b></p>
