SART Meeting minutes

Sept 4, 2024

Called to order at 9:50

Matt- Scores going up. Powerpoint: 83% of 11th grade students met standards in 23-24 for ELA. 46% for math. Still recovering from Covid downfall. Went over more detailed data by subgroup. Student Activities update: No backpack day this Friday Sept 6th- idea is to increase school culture between staff and students. Classroom goal is for teachers to lead activities all day so students can get to know each other. Rally schedule as well.

Gina- Working with all district counselors in teams and professional development to work to serve all students. Core curriculum- Academics, College and Career and Social/Emotional. September in Counseling: 12th grade class visits- postsecondary choice presentations in gov/econ classes, help with community college apps. 11th grade history class visits for postsecondary path presentations. 10th grade Career exploration and building in World History classes, and 9th grade Transition to high school presentations. Interventions for Sept: Freshman intervention, Credit Recovery intervention (Edgenuity), EL Support and Intervention to assist with community college apps, and 504/Sped Intervention- help with college services. Parent question about CART application timeline- communication rolled out Dec through January; site visits, CART tour.

Student Services update from Matt- Cell phone policy: Not much different than before. Phones must be put away during instructional time, including restroom breaks. Still able to use it during passing period and lunch. Off to a great start. Parent question about tardy system. Baljit- doors locked after bell rings and tardy students must go to student services for a pass. Parents immediately notified by email, working on a text system. Helping create behaviors they need as adults.

School Safety by Baljit- Catapult EMS- communication tool to account for students and staff for emergencies and drills. Doors must also be locked during class time for safety. There's a trigger system in Catapult to automatically lock most outside building doors. Safety drills once a month. Parents notified by Baljit the night before. Post drill update as well. Student IDs- 2nd year using digital ID's through Student Connect. No longer provided a

physical ID card by Larson. Special Ed students will receive a physical ID if needed and case by case requests by others will be fulfilled as well- working on setting up a system to do that through Becki Porcella's office. Parent question- she does not have social media and wondering if she is missing out on info. Baljit mentioned Facebook, Instagram (Activities) and the new Parent Square program being rolled out for ALL parent communication. Beth Willson sends out a weekly newsletter on Sunday afternoons by email and text.

Bond 2024 by Matt- At a Glance powerpoint: 2020 bond to start Clovis South. 4900 students at REC and severely impacted. Need the 2024 bond to pass so Clovis South can be finished and open as a high school. Otherwise it will just be a junior high. Recommended by Citizens of CUSD. On November 4th ballot. Will not increase the tax rate. Will just extend it. Needed because the 2020 bond funds are spent or committed, more than 30 schools over 30 years old, and post pandemic costs for construction are rising exponentially. Bond will benefit ALL students at all schools. Clovis High plans for bond funds- safety enhancements, LED lighting upgrades, roof replacement, repair portables, Merriman bleachers replacement. If our bond passes, we will get matching dollars from the state. Parent question- can bond be used for salaries? NO. Purely for facilities.
