

Clovis East High School Parking Permit Information

Students at Clovis East High School who wish to park on campus must have a valid parking permit displayed. In order to receive a parking permit, vehicle information must be on file with the school, a \$10 parking permit fee paid, and the student's driver's license verified by staff. Parking permits are valid until the last day of school in an academic year.

Vehicle information is gathered during the Annual Re-Enrollment Process. If the parent/guardian has not already provided that information, here are the steps to do so:

1. Login to ParentConnect.
2. Click on Annual information update in the upper right corner.
3. Click the student you want to add vehicles to.
4. On the left, click on "Reagan Educational Center Downloads".
5. If you have not already acknowledged the rules, download, and acknowledge the rules. You may need to enter your student's driver's license ID if you have not previously done so.
6. Click "Add" to add new vehicles. Enter year, make, model, color, and license plate of the vehicle. Repeat for each vehicle the student may drive to campus.
7. Click the check at the bottom.
8. Click the submit button at the top.

Once these steps are completed, the student may come into the Activities Office with their driver's license and fee payment of \$10 to receive their parking permit. The Activities Office accepts cash, check, or physical card payments. The parking permit fee may also be paid online at clovisusd.revtrak.net.

PARKING PERMIT RULES & REGULATIONS

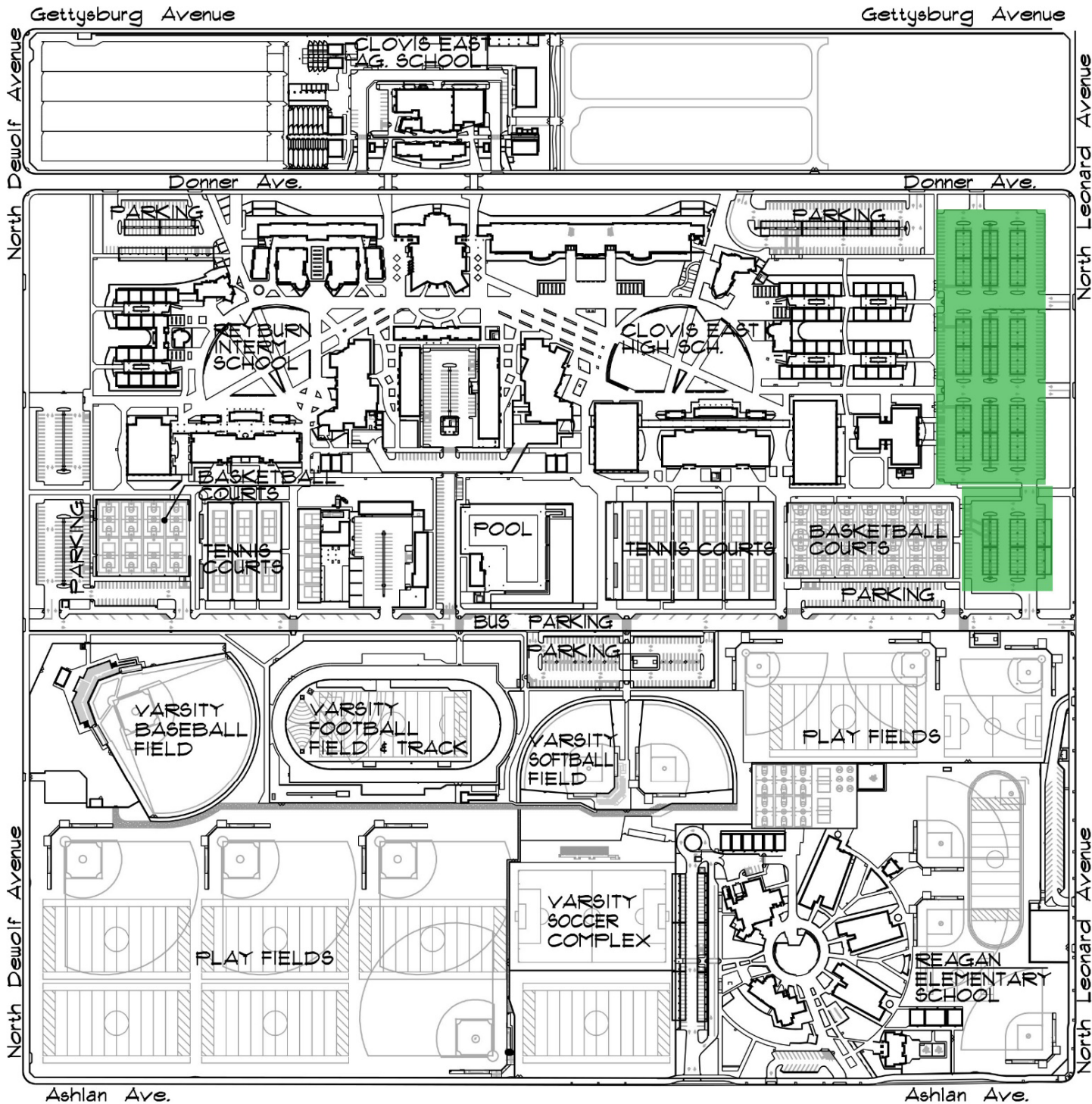
- Students must park in the student lot located on Leonard Avenue, east of the campus.
- Students must purchase a parking pass of \$10.00 in the Activities Office prior to driving a vehicle to school.
- A pass valid for the current school year must be properly displayed from the rearview mirror at all times.
- Current parking permits from other Clovis Unified schools are valid in the Clovis East student parking lot.
- Students may not loiter in the parking lot or in any vehicle once parked in the student lot; they should proceed onto the campus.
- The student parking lot is **OFF LIMITS** to students during regular school hours.
- At no time during the school day are students to access the lot or any vehicle, this includes break, lunch, and during passing periods.
- Driving to school is a privilege, not a right. Erratic or unsafe driving may result in the loss of the student parking permit and driving privileges to school and off-campus privileges for seniors.

CLOVIS UNIFIED PARKING ORDINANCES

Tickets and fines will be given for the following:

- Parked without current valid permit displayed.
- Student parking in Staff and/or restricted parking.
- Parked in disabled space without permit.
- Parked where specifically prohibited.
 - RED curb
 - GREEN curb for longer than the designated time
 - YELLOW curb loading and unloading for longer than designated time
 - Within 15 feet of a fire hydrant
- Parked in temporary visitor area.
- Park, stop, or leave vehicle in Ag area, impeding movement of any vehicle, farm machinery or equipment.
- Vehicles parked on campus that do not comply with regulations.
- Vehicles not parked completely in stalls in areas marked.
- Parked vehicles must have front wheel within 18 inches of curb.
- Parked vehicles **SHALL NOT** be **BACKED** into stalls.
- Vehicles parked along roadways must be parallel and facing the direction of traffic.
- Inside wheels of parallel-parked vehicles must be within eighteen inches of the right-side curb.
- Disobey a posted **No Parking** sign or direction of any CUSD officer.
- No driving, parking/stopping on driveways, sideways, landscape areas, not improved areas, (including parking lot cement dividers).
- Use of altered, substituted, expired, or unauthorized parking permit.
