PETITION DESCRIPTION
EDUCATION CODE § 35705.5(b)

The territory transfer petition proposes the transfer of the neighborhood currently under development commonly known as Ventana Hills, along with multiple parcels of undeveloped land to the West, out of the Sierra Unified School District and into the territory of the Clovis Unified School District.

Pursuant to Education Code, section 35705.5, subd. (b), at least 10 days before the public hearing, or hearings, on the petition, the county committee shall make available to the public and to the governing boards affected by the petition a description of the petition, including all of the following:

(1) The rights of the employees in the affected districts to continued employment.

The rights of school district employees in school district reorganizations are described generally in Education Code, sections 35555 through 35559. At this time, it is uncertain whether the proposed transfer of territory will or will not affect any district employees' right to continued employment.

(2) The local control funding formula allocation pursuant to Section 42238.02, as implemented by Section 42238.03, per pupil, for each affected district and the effect of the petition, if approved, on that allocation.

Due to the limited number of students currently encompassed by the proposed territory transfer, there is no measurable anticipated effect on the per pupil allocation for either district at this time. However, the results of the territory transfer, if approved, may impact the per pupil allocation in the future if the property in the territory continues to be developed and additional students move into the transferred area.

(3) Whether the school districts involved will be governed, in part, by provisions of a city charter and, if so, in what way.

(4) Whether the governing boards of any proposed new district will have five or seven members.

Not applicable to this petition.

(5) A description of the territory or school districts in which the election, if any, will be held.

As a part of its review of the petition, the Fresno County Committee on School District Organization will determine the territory or school districts in which the election, if any, will be held pursuant to the circumstances surrounding the transfer and applicable law.

(6) Where the proposal is to create two or more new districts, whether the proposal will be voted on as a single proposition.

Not applicable to this petition.

(7) Whether the governing board of any new district will have trustee areas and, if so, whether the trustees will be elected by only the voters of that trustee area or by the voters of the entire school district.

Not applicable to this petition.

(8) A description of how the property, obligations, and bonded indebtedness of original districts will be divided.

The area of the proposed territory transfer does not contain any public school real property. If the transfer is approved, the plans and recommendations of the Fresno County Committee on School District Organization would dictate the division of any other property, funds, or obligations affected by the proposal. Absent any provisions of the County Committee to the contrary, if the transfer is approved the territory transferred would assume its proportionate share of any outstanding bonded indebtedness of the district of which it becomes a part.

(9) A description of when the first governing board of any new district will be elected and how the terms of office for each new trustee will be determined.

Pursuant to Education Code Section 35700, subdivision (a), the undersigned, constituting at least 25 percent of the registered voters residing in the territory proposed to be transferred, now within the boundaries of the Sierra Unified School District, Fresno County, petition that the boundaries of the Sierra Unified School District be changed to eliminate from it the territory hereinafter described. The undersigned persons petition that the territory be transferred to and included within the Clovis Unified School District of Fresno County.

The property to be transferred is described as follows:

Lots 1-91 and Outlots A-R of "Map of Tract No. 5100, Ventana Hills," recorded in the County of Fresno on March 9, 2005 in Volume 71 of Plats, at pages 84 thru 92. This territory transfer proposal also includes the land contained within Fresno County APNs 300-061-29, 300-061-30, 300-061-59, 300-061-62, 300-420-29S, 300-420-04S, 300-420-25S, 300-542-19, 300-542-20, 300-542-21, 300-542-22, 300-542-23. 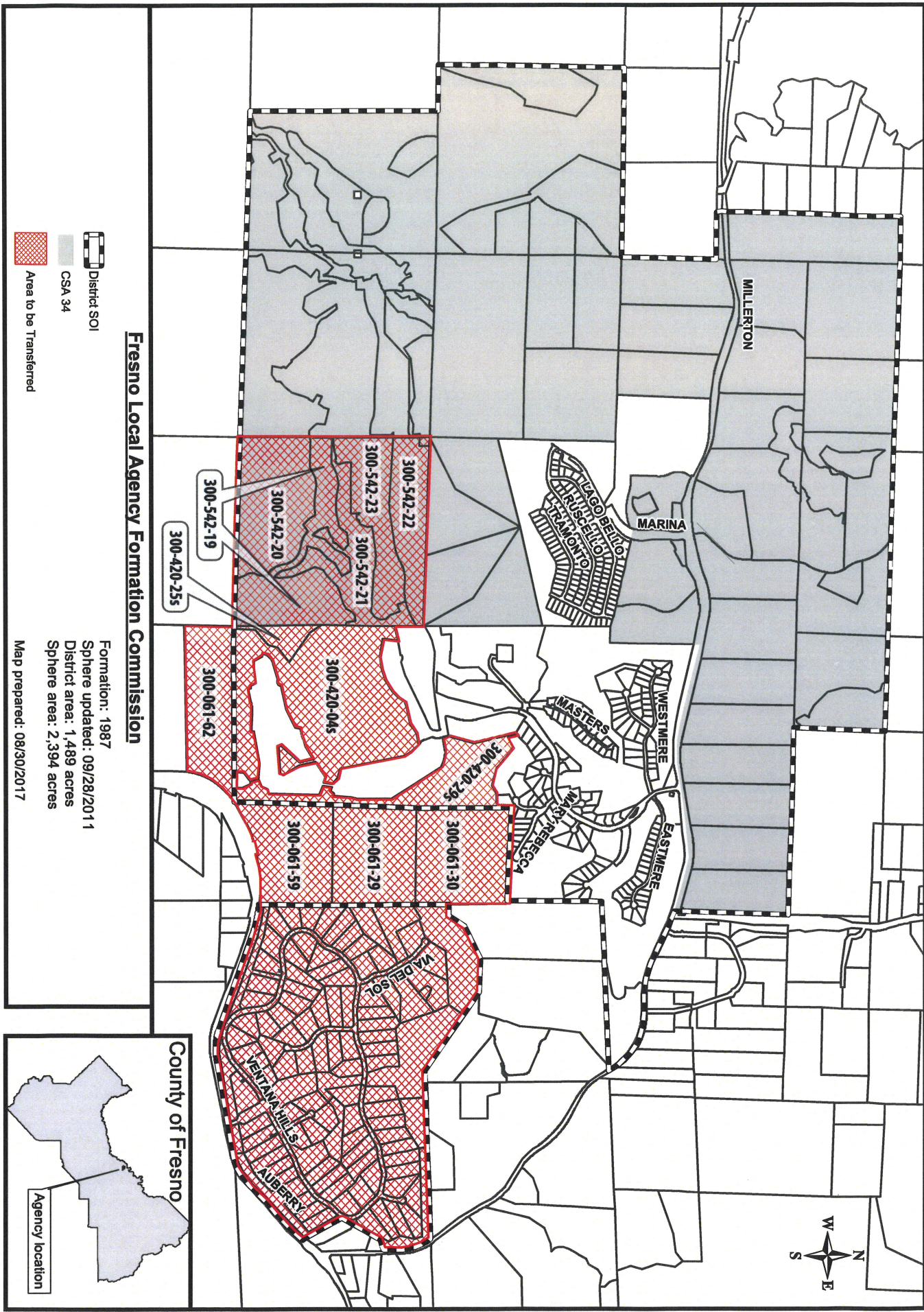

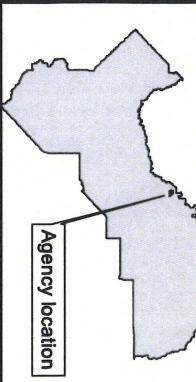
