

The deficit for 2021-22 is primarily the result of posting carryover from prior years. The District placed orders for over 20,000 student devices last year. Due to supply change issues the devices were not received by yearend, the orders rolled forward and unspent funds were posted as carryover for the current year. At year end 2020-21 the District reported assigned components of the unrestricted ending fund balance equal to \$18.2 million, these funds were added back into the expenditure budget in 2021-22. Additionally, the Board approved a 5.5% salary schedule increase for all employees.
