

She also let the committee know that the district receives state funding through LCFF.She described the role of the PAC Members in relation to the categorical funds and expressed the Title I fund based on free and reduced lunch, so she encourages parents to fill out the form to see if even if you are not sure that you are qualified.Dr. Pa Vue then reviewed funding sources related to LCFF including.Dr. Pa Vue then provided an overview of the process of the LCAP and highlighted the goals that the district looks at.
