- ◆ Qhov Willliam’s Settlement complaints yog hais txog tej yam xwsli khoom qhia ntawv, xwm ceev lossis tej chaw uas yuav tsis cobphum rau menyuam, thiab tsis muaj xibfwv lossis qhia ntawv tsis zoo, tej no yog tej yuav mus hais. Tsev kawm ntawv yuav tsum muaj cov ntaub ntawv mus hais no kom txawm peem. Tab txawm tsis siv daim ntawv hais no es ho sau mus xwb los tsev kawm ntawv yuav tsum txais.

Tus Neeg Hais Mus Yuav Ua Cas?

Tus neeg hais mus:

- ◆ Yuav tau txais tej ntaub ntawv qhia kabke ua uas pawg tsev kawm ntawv xa los thiab muab xyuas kom meej.
- ◆ Ua daim ntawv hais no kom raws li pawg tsev kawm ntawv txoj kabke es muab xa mus.
- ◆ Muab tej ntaub ntawv thiab povthawj mus rau pawg tsev kawm ntawv cov neeg ntsuam xyuas teebmeem.

- ◆ Ua ntawv mus appeal hauv California Department of Education (CDE) tsis pub dhau 15 hnuv seb yus xav tias pawg tsev kawm ntawv ua txhaum li cas.
- ◆ Mus hais txog yam twg yam ntawd rau lub CDE tias vim li cas pawg tsev kawm ntawv cov lus ho tsis yog lossis ua tsis yog cai. Tsab ntawv appeal no yuav tsum luam daim qub lus uas xa rau pawg tsev kawm ntawv thiab pawg tsev kawm ntawv qhov kev txiav txim.
- ◆ Ua ntawv mus thov daim ntawv rov hais dua hauv State Superintendent of Public Instruction (SPI) tsis pub dhau 35 hnuv yog yus xav tias qhov CDE nrhiav pom ntawd tsis yog lossis txoj cai siv tsis yog lawm.

Pawg Tsev Kawm Ntawv Yuav Ua Cas?

Pawg Tsev Kawm Ntawv:

- ◆ Yuav tsum xyuas kom cov lus hais ntawd raug raws li Tsoomfwv thiab Xeev txoj cai.
- ◆ Yuav tsum txais tej kev thiab tej kabke tuaj hais tab txawm tias ua tsis raws li California Code of Regulation, Title 5, Nqe 4600 – 4687 los xij.
- ◆ Nrhiav cov neeg los ua cov txais, xyuas tej ntaub ntawv, thiab hais tej teebmeem kom tiav.
- ◆ Txhua xyoo yuav tsum tshaj rau tsoom niamtxiv, cov ua haujlwm, tej koomhaum, menyuam kawm ntawv thiab lwm pab neeg uas txaus siab los hais txog tej no, tias lawv muaj cai los tsis pomzoo txog Pawg tsev kawm ntawv tej kev txiav txim. Yuav tsum qhia lawv txog kev nrhiav kws lijchoj. Kev tshaj tawm yuav tsum (a) hais ua lus Askiv; (b) hais ua tus menyuam hom lus yog tias ntawd muaj 15 feempua lossis tshaj saud hais nws hom lus.
- ◆ Ceev ob tog lus kom koobpheej.
- ◆ Siv cov kabke raws li hauv qab no:
 1. Yog yus pom tias leej twg, txoj kev pab twg, lossis lub koom txoos twg tau ua txhaum tsoomfwv thiab Xeev txoj cai, yus yuav tau ua ntawv mus hais tus uas ua txhaum hauv pawg tsev kawm ntawv ntawd.
 2. Tus neeg hais mus no yuav tsum yog tus uas raug lawm tus ntsub ntxaug lossis saib tsis taus. Yuav tsum hais mus tsis pub dhau rau lub hlis txij thaum qhov teebmeem tshwm sim, los yog thaum nws muab tau povthawj tseeb. Pawg tsev kawm ntawv yuav tsum tiv thaiv ob tog thiab nkawd tej kev tshwmsim.

- ◆ Hais kom tas thiab ua ntawv tshaj tawm tsis pub dhau 60 hnuv txij hnuv tau txais cov lus coj mus hais. Pawg tsev kawm ntawv yuav tsum cia nws los qhia txog nws li kev tsis taus siab. Tsev kawm ntawv yuav tsum qhia tias nws muaj cai mus hais ntxiv rau hauv CDE li 15 hnuv tom qab nws txais tau pawg tsev kawm ntawv qhov kev txiav txim yog tias nws tsis txaus siab.

Lub CDE Yuav Ua Cas?

Lub California Code of Regulations, Title 5, Section 4610 authorizes CDE, mus txog rau lub UCP tsuas ua rau cov menyuam uas raug cais pab pawg los yog cov koomhaum thov nyiaj uas yuav tau ua raws li tsoomfwv thiab Xeev txoj cai es pawg tsev kawm ntawv ho tsis pomzoo rau yam puav ntawd xwb.

- ◆ Lub CDE: Xyuas, Tsoomkwm, thiab pab txog kev ua ntaub ntawv rau txhua pawg tsev kawm ntawv hais txog kev yuav siv UCP tej kabke coj los hais.
- ◆ Xa txhua tsab lus tsis txaus siab mus rau hauv pawg tsev kawm ntawv es muab hais kom tas yog tias tsim nyog lawm.
- ◆ Nrhiav txhua txoj kev los pab daws tej lus sib liam lub caij mus txiav txim yog thaum:
 1. Pawg tsev kawm ntawv tsis hais li 60 hnuv ntawd.
 2. Tus mus hais ntawd muaj cai tsis yuav li pawg tsev kawm ntawv qhov kev txiav txim yog nws pom tias qhov ntawd tsis tseeb thiab tsis yog cai lawm.
 3. Pab neeg saib xyuas txog qhov no yuav tau qhia tias yuav ua li cas ntxiv.
- ◆ Pawg tsev kawm ntawv yuav tau kho tej ntaub ntawv dua yog tias cov lus ntawd muab nug tas tsis muaj dabtsi.
- ◆ Nrhiav neeg tsoomkwm thiab pab ua ntaub ntawv rau cov pawg tsev kawm ntawv kom meej tseeb tias cov lus ntawd yeej tsis rov hais ntxiv lawm.
- ◆ Tso cai rau ob tog kom muaj cai mus muab CDE cov lus sau mus rau lub SPI coj los hais dua nyob rau hauv 35 hnuv txij li tau muab cov lus hais ntawd zwm tseg.
- ◆ Tso cai rau ob tog kom muaj cai mus muab CDE cov lus zwm tseg mus hais rau hauv United States Secretary of Education txog cov koomhaum uas saib xyuas los ntawm Part 76 qhov Title 34 nyob rau tus Code of Federal Regulations.
