#### School Profile

Palm View Elementary provides instruction for students in grades TK-6 grade. During the 2020-2021 school year, a total of 426 students were enrolled which was comprised of: 94.1% socioeconomically disadvantaged students, 47.7% English Learners, 13.4% students with disabilities, 11.7% Migrant students, 0.7% Homeless Youth, and 1.6% Foster Youth.

#### 2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

All textbooks used in the core curriculum at Palm View Elementary are being aligned to the Common Core State Standards. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's adoption cycle for core content materials (English/language arts, math, science, and social science).

On September 16, 2021 the Coachella Valley Unified School District's Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution No. 2022-06 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social, science, and English/language arts, including the English language development component of an adopted program, 3) sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and 4) laboratory science equipment was available for science laboratory classes offered in grades 9-12, inclusive.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2021-22 school year, Coachella Valley Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

#### **School Facility Conditions and Planned Improvements**

Palm View Elementary opened its doors to a brand new campus this school year after being completely demolished in 2019. We have a multipurpose room with a theatre stage and indoor basketball courts. There is an open concept library/computer and STEM room. We are the first school in the district to have a two story building.

District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. Emergency repairs are given the highest priority. Every morning before school begins, the custodian inspects the school perimeter and facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. One day custodian and one evening custodian is assigned to Palm View Elementary School. Restrooms are checked regularly throughout the day for cleanliness and subsequently cleaned as needed.

The day custodian is responsible for:

- Multi Purpose Room
- General Maintenance
- Library
- Offices
- Restrooms
- Teacher Workroom and Lounge

The evening custodian is responsible for:

- Classrooms
- Restrooms
- Multi Purpose Room

The Principal communicates with custodial staff daily concerning maintenance and school safety issues.

• Construction of a new play field.

#### Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, yard duty supervisors are strategically assigned to designated entrance areas, the breakfast area and playground. During recess, teachers supervise playground activity. Yard duty supervisors monitor lunch time activity in the cafeteria and on the playground. At the end of the day when students are dismissed, teachers monitor student behavior to ensure a safe and orderly departure. Palm View Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office and wear identification badges while on school grounds

Condition of Facilities - Riverside County Williams Inspection Results

On an annual basis, representatives from the Riverside County Office of Education visit Coachella Valley Unified School District's schools that are in the API Decile Ranks 1-3. The inspection is designed to evaluate and verify that school facilities conditions are in "good repair" and that any deficiencies are accurately reported in the School Accountability Report Cards.
