MINUTES of a regular public meeting of the Board of Education of COUNTY CLERK Community Unit School District Number 10, Madison and St. Clair Counties, Illinois, held at the Unit #10 Administrative Annex, 123 W. Clay, Collinsville, Illinois, in said School District at 6:30 o'clock P.M., on the 18th day of December, 2023.

The President called the meeting to order and directed the Secretary to call the roll.

The President announced that the Board of Education would next consider the adoption of
a resolution providing for and requiring the submission of the proposition of increasing the existing
tax rate for operations and maintenance purposes to the voters of the District at the general primary
election to be held on March 19, 2024.
Whereupon Member Sochlko presented and the Secretary read by title
a resolution as follows, a copy of which was provided to each member of the Board of Education
prior to said meeting and to everyone in attendance at said meeting who requested a copy:

COUNTY CLERK

RESOLUTION providing for and requiring the submission of the proposition of increasing the existing tax rate for operations and THOMAS HOLBROOK maintenance purposes to the voters of Community Unit School District Number 10, Madison and St. Clair Counties, Illinois, at the general primary election to be held on the 19th day of March, 2024.

WHEREAS, the Board of Education (the "School Board") of Community Unit School District Number 10, Madison and St. Clair Counties, Illinois (the "District"), is presently authorized to levy a tax annually for operations and maintenance purposes at the rate of 0.50 percent upon all the taxable property of the District at the value, as equalized or assessed by the Illinois Department of Revenue (the "Department of Revenue"); and

WHEREAS, the School Board does hereby find and determine that the existing tax rate for operations and maintenance purposes is not sufficient to provide funds to pay the cost of providing an efficient and adequate program to meet the educational needs of the District; and

WHEREAS, the School Board hereby finds and determines that the need exists for increasing the present operations and maintenance tax rate of the District and establishing the same at 0.72 percent upon all the taxable property of the District at the value, as equalized or assessed by the Department of Revenue; and

WHEREAS, before the School Board is authorized to levy taxes at an increased rate for operations and maintenance purposes, a proposition therefor must be submitted to the voters of the District as provided by Article 17 of the School Code of the State of Illinois, as amended, and approved by a majority of the voters of the District voting on such proposition at an election to be held in and for the District; and

WHEREAS, the School Board hereby deems it advisable, necessary and in the best interests of the District that the proposition of increasing said operations and maintenance tax rate and establishing the same at the rate of 0.72 percent be submitted to the voters of the District at an election to be held and conducted in accordance with the general election law:

Now, Therefore, Be It and It Is Hereby Resolved by the Board of Education of Community Unit School District Number 10, Madison and St. Clair Counties, Illinois, as follows:

Section 1. That the School Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. That it is advisable, necessary and in the best interests of the District that in order for the District to maintain and operate an efficient system of schools the present annual tax rate of the District for operations and maintenance purposes be increased to 0.72 percent upon all the taxable property of the District at the value, as equalized or assessed by the Department of Revenue.

Section 3. That the proposition hereinabove referred to shall be submitted to the voters of the District in accordance with the general election law at the general primary election to be held on Tuesday, the 19th day of March, 2024, between the hours of 6:00 o'clock A.M. and 7:00 o'clock P.M. of said day (the "Election").

Section 4. That the Election shall be held in the voting precincts and at the polling places established by the County Boards (the "County Boards") of The Counties of Madison and St. Clair, Illinois (the "Counties"), for voters of the District at the Election.

Section 5. That the County Clerks of the Counties (together, the "County Clerks") shall give notice of the Election (the "Notice") in accordance with the general election law by (i) publishing the Notice once not more than 60 nor less than 10 days prior to the date of the Election in a local, community newspaper having general circulation in the District, and (ii) posting a copy of the Notice at least 10 days before the date of the Election at the principal offices of the County Clerks.

Section 6. That the Secretary of the School Board shall post a copy of the Notice at the principal office of the District at least 10 days before the date of the Election.

Section 7. That it is hereby found and determined that the *Times-Tribune* is a local, community newspaper having general circulation in the District as required by Section 12-5 of the Election Code of the State of Illinois, as amended (the "Election Code").

Section 8. That the Notice shall appear over the names or titles of the County Clerks and shall be substantially in the following form:

NOTICE IS HEREBY GIVEN that at the general primary election to be held on Tuesday, the 19th day of March, 2024, the following proposition will be submitted to the voters of Collinsville Community Unit School District Number 10, Madison and St. Clair Counties, Illinois:

Shall the maximum annual tax rate for operations and maintenance purposes for Collinsville Community Unit School District Number 10, Madison and St. Clair Counties, Illinois, be increased and established at 0.72 percent upon all the taxable property of said School District at the value, as equalized or assessed by the Department of Revenue, instead of 0.50 percent, the present maximum rate otherwise applicable to the next taxes to be extended for said purposes?

- (a) The approximate amount of taxes extendable for operations and maintenance purposes under the maximum rate now in force in said School District is \$4,911,936.
- (b) The approximate amount of taxes extendable for operations and maintenance purposes under the proposed increased rate is \$7,073,188.
- (c) The total dollar amount of expected revenues in the most recently approved annual budget of said School District is \$95,157,200; the total dollar amount of said revenues, if increased by the amount of additional tax which may be levied if the proposition is approved, is \$97,318,452; the percentage of increase in the total dollar amount of expected revenues in the most recently approved annual budget of said School District, if such total dollar amount were increased

by the amount of additional tax which may be levied if the proposition is approved, is 2.3 percent.

(d) The percentage of increase between the maximum rate at which such taxes for operations and maintenance purposes may be levied if the proposition is approved and the annual rate at which such taxes for operations and maintenance purposes is currently levied is 44.0 percent.

The polls at the election will be open at 6:00 o'clock A.M. and will continue to be open until 7:00 o'clock P.M. of that day.
