#### **RESOLUTION**

BOND RESOLUTION OF THE COPIAGUE UNION FREE SCHOOL DISTRICT, NEW YORK, ADOPTED NOVEMBER 23, 2009, AUTHORIZING THE PARTIAL RECONSTRUCTION OF, AND CONSTRUCTION OF ALTERATIONS AND IMPROVEMENTS TO, THE COPIAGUE MEMORIAL PUBLIC LIBRARY; STATING THE ESTIMATED MAXIMUM COST THEREOF IS NOT TO EXCEED \$1,865,000; APPROPRIATING SAID AMOUNT THEREFOR; INCLUDING \$365,000 IN FUNDS ON-HAND IN THE COPIAGUE MEMORIAL LIBRARY'S CAPITAL RESERVE FUND; AND AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$1,500,000 SERIAL BONDS OF SAID DISTRICT TO FINANCE THE BALANCE OF SAID APPROPRIATION.

#### **Recital**

WHEREAS, at the Special District Meeting duly held on October 27, 2009, in the Copiague Union Free School District, in the County of Suffolk, New York (the "District"), the qualified voters present and voting approved a proposition authorizing the partial reconstruction of, and construction of alterations and improvements to, the Copiague Memorial Library, at the estimated maximum cost of \$1,865,000, or so much as may be necessary; and such qualified voters further authorized the Board of Education to levy and collect a tax to be collected in annual installments to pay a portion of such cost;

Now, therefore,

THE BOARD OF EDUCATION OF THE COPIAGUE UNION FREE SCHOOL DISTRICT, IN THE COUNTY OF SUFFOLK, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Board of Education) AS FOLLOWS:

Section 1. The Copiague Union Free School District, in the County of Suffolk, New York, is hereby authorized to partially reconstruct and construct alterations and improvements to the Copiague Memorial Public Library substantially as referred to and described in a summary prepared with the assistance of John A. Grillo, Architects, including the construction of a partial second floor within the existing Library structure to provide for additional adult room reading space, computer space, group meeting space and individual study spaces; the foregoing to include associated HVAC, handicapped accessibility and structural improvements, and all original furnishings, equipment, machinery, apparatus and all ancillary or related work required in connection therewith. The estimated maximum cost thereof, including preliminary costs and costs incidental thereto and to the financing thereof, is \$1,865,000 and said amount is hereby appropriated therefore, including the appropriation of \$365,000 in funds on-hand in the Copiague Memorial Library's capital reserve fund. The plan of financing includes the expenditure of said \$365,000 and the issuance of \$1,500,000 bonds or notes of the District to finance the balance of said appropriation, and the levy and collection of taxes on all the taxable real property in the District to pay the principal of said bonds or notes and the interest thereon as the same shall become due and payable.

Section 2. Serial bonds of the District in the amount of \$1,500,000 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33- a of the Consolidated Laws of the State of New York (herein called "Law") to finance a portion of said appropriation.

Section 3. The following additional matters are hereby determined and declared: (a) The period of probable usefulness applicable to the purpose for which serial bonds are authorized to be issued pursuant to this resolution, within the limitations of Section 11.00 a. 12. (a)(1) of the Law, shall not exceed twenty-five (25) years.

(b) The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the District for expenditures made for the purpose or purposes for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 4. Each of the bonds authorized by this resolution and any bond anticipation notes issued in anticipation of the sale of said bonds shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds and any notes issued in anticipation of said bonds shall be general obligations of the District, payable as to both principal and interest by general tax upon all the taxable real property within the District without limitation of rate or amount. The faith and credit of the District are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds and any notes issued in anticipation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 5. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds with substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes and Section 50.00 and Sections 56.00 to 60.00 of the Law, the powers and duties of the Board of Education relative to authorizing bond anticipation notes and prescribing the terms, form and contents and as to the sale and issuance of all bonds herein and heretofore authorized and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said bond anticipation notes, are hereby delegated to the President of the Board of Education, the chief fiscal officer of the District.

Section 6. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

(a) such obligations are authorized for an object or purpose for which the District is not authorized to expend money, or

(b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary hereof, are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 7. This bond resolution shall take effect immediately, and the District Clerk is hereby authorized and directed to publish the foregoing resolution, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in "*The Beacon*" and "*The Amityville Record*" two newspapers each having a general circulation within the District and hereby designated the official newspapers of said District for such publication.
