The meeting was called to order at 5:15 p.m. by Mr. Brian J. Sales, President of the Board of Education in the Middle School Auditorium.

Mr. Sales: Before we begin the public portion of the meeting, I would like to take a moment to provide you with some facts.

Earlier this year the governor was hinting on potential cuts ranging from 5 – 50% depending on the state's finances, but we were told that he would give a clearer picture during the April and June measurement periods. With that in mind, during the construction of this year's budget we prepared for a number of pandemic-related contingencies, including a possible reduction to our state aid.

Historically, a reduction in state aid has only affected a district's Foundation Aid. We prepared for that reduction by cutting 2 million dollars from a 2019/2020 rollover budget to arrive at this year's budget and set aside limited reserves to assist in offsetting the expected reductions.

However, both the April and June measurement periods came and went with no information from the Governor. Then on August 20<sup>th</sup> we received a state aid payment related to the 2019/2020 school year that was 20% less than expected and which equated to \$916,094. Along with that payment was a link to a notice that all future state aid payments would also be reduced by 20%. Despite no prior indication from the Governor, we were also advised that the state is not limiting the reduction to just Foundation Aid but is subjecting the reduction to all "mandated payments." which includes all expenditure driven aids. Additionally, we have been advised that it will also impact our STAR payments, further reducing revenue.

While the state is currently defining these reductions as "withholdings" they make it clear that in the absence of federal action these reductions will become permanent.

In Copiague almost half of our revenue comes from state aid so a 20% cut equates to almost \$13 million, and any STAR reductions would be a further reduction of an additional 1.2 million

After being a part of our numerous successes over the years it was incredibly sad and upsetting to have been forced to make the cuts to staff and programs that were made last week. Excessing any staff member – no matter their years of service – is never easy. These individuals are not just a name on a piece of paper, they are part of our Copiague Family. These cuts, the lack of financial equity among school districts on Long Island, and the late notice from the state are beyond our control but deeply affect our children and our district.

While many have said that they expect the next stimulus package to include aid for education, each of our monthly aid payments will continue to be reduced by 20% until that happens.

I would encourage everyone to help us in our fight for equity to let our elected officials know that we deserve our fair share of aid because our students should have the absolute best that this country can offer.
