WHEREAS, the Board has determined that the economic and organizational interests of the Copiague U.F.S.D. are best served by effectuating said recommendation,

NOW THEREFORE, BE IT RESOLVED THAT:

- 1. The Board herewith abolishes the position of Executive Director of Instructional Support, effective September 7, 2022; the incumbent in said position is Karla Cangelosi.
- 2. The Board herewith creates the position of Deputy Superintendent, effective September 7, 2022 simultaneously with the abolishment of the aforementioned position of Executive Director of Instructional Support.
- 3. Based upon information provided by the Superintendent, the incumbent of the position of Executive Director of Instructional Support, Karla Cangelosi, is entitled as a matter of law to appointment to the position of Deputy Superintendent, effective September 7, 2022. In connection with the foregoing, the Board has determined that fifty percent (50%) or more of the duties of said current position of Executive Director of Instructional Support will be subsumed within the newly created position of Deputy Superintendent. Therefore, based upon the Education Law of the State of New York and the advice of counsel, the incumbent in the position abovementioned, to with Karla Cangelosi, is herewith appointed to the position of Deputy Superintendent. Further, based upon the past meritorious service of Karla Cangelosi, she is herewith appointed with tenure to the position of Deputy Superintendent, effective September 7, 2022. The salary and benefits for Karla Cangelosi in her position of Deputy Superintendent shall be memorialized in an individual employment contract.
