## Leadership

**New certification requirements:** House Bill 1537 amends the requirement for certain educators to renew their professional certificate in educational leadership. For individuals who hold a certificate in educational leadership, the individual must earn a minimum of one college credit or 20 in-service points in Florida's Educational Leadership Standards (FELS) to renew their professional certificate with renewals beginning July 1, 2025 or later.

The courses listed below meet the criteria for the new Florida Department of Education (FLDOE) requirement of leadership in-service hours for teachers with a certification in education leadership. Please note the number of hours awarded for the course (not all courses satisfy the full 20-hour requirement, and additional leadership courses may be needed).
