assumptions to BOE.

March 1, 2021 Submit 2021-2022 calculation for tax levy limit to NYS

Comptroller, Commissioner of NYS Department of Education; and Department of Taxation and Finance.

March 16, 2021 Present updated 2021-2022 draft budget to the Board of

Education.

March 19, 2021 Voter propositions must be submitted to the Board of

Education by Friday, March 19, 2021.

April 1-2, 2021 First Legal Notice of school budget hearing and budget

vote. Must advertise four times in 2 newspapers within seven weeks of the vote with first publication 45 days before date of budget vote. April 1-2, 15-16, April 29-30,

May 13-14.

April 19, 2021 Deadline for submission of petitions for nominations of

BOE candidates 30 days prior to election. Inform

candidates of legal requirements to file sworn statements of campaign contributions due 30 days prior to vote; first

campaign expenditure statement due.

April 20, 2021 Final draft of 2021-2022 Budget presented to Board of

Education for adoption; appointment of clerks and

inspectors of elections for budget vote.

May, 2021 Mail district budget newsletter and post on website.

May 4, 2021 Budget Hearing. Budget statement available 7 days prior

to budget hearing, the proposed budget made available on

district website.

May 11, 2021 Copies of Budget made available to residents upon

request.

May 11, 2021 Last day to submit Absentee Ballot applications if the

ballot is to be mailed, May 17, 2021 if the ballot is to be personally delivered. District Clerk must maintain list of

names that were given absentee ballots.

May 12, 2021 Budget notice mailed to eligible voters- no later than six

days prior to budget vote.

May 13, 2021 Second sworn statements of campaign contributions or

loans in excess of \$1,000 received before vote date, to be filed with District Clerk and Commissioner of Education

within twenty-four hours of receipt by candidates.

May 13, 2021 Last possible day for voter registration; registration

available 4:00-8:00 pm in the school cafetorium. Voter

registration available for inspection. Campaign

expenditure second statement due.

May 18, 2021 Budget Vote/ Board Election Date.

Receipt of Absentee Ballots no later than 5:00 PM.
