December 21, 2021	Adopt 2022 – 2023 Budget Development Calendar.
January, 2022	Begin meeting with budget builders.
January, 2022	Discuss budget parameters with Board of Education, expected Gov. Executive Proposal State Aid.
February 15, 2022	Present 2021-2022 preliminary budget forecast and assumptions to BOE.
March 1, 2022	Submit 2022-2023 calculation for tax levy limit to NYS Comptroller, Commissioner of NYS Department of Education; and Department of Taxation and Finance.
March 15, 2022	Present updated 2022-2023 draft budget to the Board of Education.
March 18, 2022	Voter propositions must be submitted to the Board of Education by Friday, March 18, 2022.
March 31, April 1 2022	First Legal Notice of school budget hearing and budget vote. Must advertise four times in 2 newspapers within seven weeks of the vote with first publication 45 days before date of budget vote. March 31-April 1, April 14-15, April 28-29, May 12-13.
April 12, 2022	Final draft of 2022-2023 Budget presented to Board of Education for adoption; appointment of clerks and inspectors of elections for budget vote.
April 18, 2022	Deadline for submission of petitions for nominations of BOE candidates 30 days prior to election. Inform candidates of legal requirements to file sworn statements of campaign contributions due 30 days prior to vote; first campaign expenditure statement due.

April 20, 2022	Prepare ballots.
April 22, 2022	Distribute military ballots.
April 25, 2022	Real Property Tax Report card must be submitted to SED within 24 hours of budget adoption; submit to local newspaper; make available to public. Transmit Tax Report Card to NYSED. April 25, 2022 is legal deadline. Property Tax Exemption Report must be attached to the proposed budget.
May, 2022	Mail district budget newsletter and post on website.
May 3, 2022	Budget Hearing. Budget statement available 7 days prior to budget hearing, the proposed budget made available on district website. Copies of Budget made available to residents upon request.
May 10, 2022	Last day to submit Absentee Ballot applications if the ballot is to be mailed, May 16, 2022 if the ballot is to be personally delivered. District Clerk must maintain list of names that were given absentee ballots.
May 11, 2022	Budget notice mailed to eligible voters- no later than six days prior to budget vote.
May 12, 2022	Second sworn statements of campaign contributions or loans in excess of \$1,000 received before vote date, to be filed with District Clerk and Commissioner of Education within twenty-four hours of receipt by candidates.
May 12, 2022	Last possible day for voter registration; registration available 4:00-8:00 pm in the school cafetorium. Voter registration available for inspection. Campaign expenditure second statement due.
May 17, 2022	Budget Vote/ Board Election Date. Receipt of Absentee Ballots no later than 5:00 PM.

Board of Registration meets during the election to register individuals for the 2022-2023 annual budget vote and election.

June 6, 2022

Last date to file final and third campaign expenditure with District Clerk and NYS Education Commissioner. Statement due 20 days after vote.

June 14, 2022

Budget Re-vote day (if necessary).

July 1, 2022

Implement 2022-2023 Budget.
