





- 1. OIL TANK LOCATIONS AND DIMENSIONS ARE APPROXIMATE. ACTUAL LIMITS TO BE LOCATED IN THE FIELD BY THE ENGINEER.
- 2. BOILER HAS ALREADY BEEN DISCONNECTED AND PIPES CAPPED.
- 3. . REMOVE TANK, PIPES AND CATHODIC PROTECTION TO BLDG. BACKFILL AREA WITH CDF TO 24" BELOW FINISH GRADE. REPAIR/FILL HOLES IN WALL FROM PIPE REMOVAL WITH GROUT TO SEAL.
- 4. SAWCUT, REMOVE AND REPAIR PAVEMENT PER DETAILS 1/1.2 AND 2/1.2. PLACE 24" TOPSOIL IN LANDSCAPE AREAS.
- 5. CONTRACTOR TO SHORE FOR EXCAVATION IF TANK REMOVAL REQUIRES EXCAVATION UNDER ADJACENT BUILDING FOUNDATION.
- 6. UTILITY SERVICES TO BLDG SHALL NOT BE DISRUPTED UNLESS APPROVED BY 4J.

CONSTRUCTION NOTES:

- 1.REMOVE AND REPLACE EX ASPHALT AS REQUIRED FOR TANK REMOVAL. REMOVE EX ASPHALT PERPENDICULAR TO TANK REMOVAL EXCAVATION. FINAL ASPHALT REMOVAL AREA TO BE RECTANGULAR IN SHAPE.
- 2. EX UTILITY LOCATIONS SHOWN ARE APPROXIMATE, BASED ON RECORD DRAWINGS AND PUBLIC UTILITY LOCATES. CONTRACTOR TO POT HOLE AND VERIFY LOCATIONS PRIOR TO TANK REMOVAL WORK. PROTECT EX UTILITIES AND REPLACE ANY COMPONENTS DAMAGED DURING EXCAVATION.
- 3. EX ELECTRICAL TRANSFORMER TO REMAIN. PROTECT CONCRETE BASE AND SHORE IF REQUIRED TO PREVENT UNDERMINING DURING EXCAVATION
- 4. EXISTING TREES TO REMAIN. REMOVE NORTH TREE IF MORE THAN 30% OF ROOTS ARE DISTURBED. COORDINATE WITH 4J IF LIMBS REQUIRE PRUNING TO ACCOMMODATE EXCAVATION EQUIPMENT.

- 5. COORDINATE WITH EWEB TO REPOUTE **ELECTRICAL SERVICE OUTSIDE EXCAVATION AREA** BEFORE BEGINNING WORK, ELECTRICAL SERVICE TO BLDG SHALL NOT BE DISRUPTED. COORDINATE WITH 4J IS TEMPORARY SHUTDOWN IS REQUIRED FOR CHANGE OVER.
- 6. COORDINATE WITH NW NATURAL TO DISCONNECT GAS SERVICE PRIOR TO **EXCAVATION AND REPLACE AFTER TANK REMOVAL** IS COMPLETE. COORDINATE WITH 4J.
- 7. BLDG SANITARY SERVICE TO REMAIN IN SERVICE. IF PIPE REQUIRES REMOVAL, INSTALL BYPASS SYSTEM.
- 8. REMOVE AND REPLACE IRRIGATION PIPE, AS REQUIRED, TO ACCOMMODATE TANK REMOVAL WORK.



- 2. EX UTILITY LOCATIONS SHOWN ARE APPROXIMATE, BASED ON RECORD DRAWINGS. CONTRACTOR TO POT HOLE AND VERIFY LOCATIONS PRIOR TO TANK REMOVAL WORK. PROTECT EX UTILITIES AND REPLACE ANY COMPONENTS DAMAGED DURING EXCAVATION.
- 3. PROTECT ELEC SERVICE. ELECTRICAL SERVICE OVER TANK TO BE RELOCATED PRIOR TO TANK REMOVAL. CONTRACTOR TO COORDINATE WITH EWEB FOR RELOCATION.

- 4. HIRE ELECTRICIAN TO REMOVE AND REPLACE GENERATOR. COORDINATE WITH 4J FOR ON-SITE STORAGE LOCATION. REMOVE GENERATOR CONCRETE PAD, AS REQUIRED, FOR TANK REMOVAL. POUR NEW CONCRETE PAD AND REPLACE GENERATOR.
- 5. REMOVE AND SALVAGE EX CHAIN LINK FENCING AROUND GENERATOR AND ADJACENT LAWN. STORAGE MATERIALS ON-SITE DURING TANK REMOVAL. REINSTALL FENCE IN EX LOCATIONS. USE NEW FENCE POSTS FOR FENCE INSTALLATION.
- 6. COORDINATE WITH NW NATURAL TO REMOVE AND REPLACE GAS SERVICE PIPING ABOVE TANK REMOVAL AREA. COORDINATE WITH 4J FOR DISRUPTION OF SERVICE.



- 1. REMOVE CONCRETE IN FULL PANELS. DO NOT REPLACE CONCRETE AND ASPHALT WALKS. BACKFILL TOP 24" ABOVE CDF IN AREAS WITHIN 6' FROM BACK OF EX CURB WITH COMPACTED $\frac{3}{4}$ "-0 CRUSHED ROCK, BACKFILL TOP 24" OF AREAS FURTHER THAN 6' ' AWAY FROM EX CURB WITH TOPSOIL AND SEED.
- 2. EX UTILITY LOCATIONS SHOWN ARE APPROXIMATE, BASED ON RECORD DRAWINGS AND PUBLIC UTILITY LOCATES. CONTRACTOR TO POT HOLE AND VERIFY LOCATIONS PRIOR TO TANK REMOVAL WORK. PROTECT EX UTILITIES AND REPLACE ANY COMPONENTS DAMAGED DURING EXCAVATION.



- 6. REMOVE EX ASPHALT PERPENDICULAR TO TANK REMOVAL EXCAVATION. FINAL ASPHALT REMOVAL AREA TO BE RECTANGULAR IN SHAPE. DO NOT REPLACE ASPHALT PAVEMENT. PLACE GRAVEL FROM TOP OF CDF TO THE SURFACE OF VEHICLE PAVEMENT AREAS. TO BE PAVED LATER BY OTHERS.
