#### CREST ELEMENTARY INTERIOR PAINTING

#### GENERAL NOTES at CREST ELEMENTARY:

- 1. The only casework to be painted is the cabinets in the Kitchen. Casework painting means finishing all surfaces as they are finished now, inside and out, including movable shelves and backs of casework.
- 2. Existing painted surfaces have numerous paint layers and bottom layers may contain lead based paint. Should suspect layers be encountered, contact District for remedy.
- Protect surfaces not to be painted from damage and debris. Repair any damage to areas during work.
- 4. Inspect, prepare for and re-caulk and seal at joint of dissimilar materials (window frames to walls, masonry, etc.).
- 5. Mask murals and cut tight with scheduled paint colors.
- 6. Remove and reinstall all wire baskets or covers protecting speakers, heating controls, etc. Remove and reinstall all mechanically fastened signage, graphics, etc, from walls, doors or surfaces to receive paint coatings.
- 10 Remove staples, fasteners, and any adhesive applied labels to wall surfaces and cabinetry prior to final coats.

#### SCOPE OF WORK at CREST ELEMENTARY:


- 1. All surfaces in areas to be painted are to be prepped, receive a <u>full</u> prime coat and painted, unless noted otherwise.
- 2. Acoustic ceilings are not to be painted. Hard ceilings in general are to be painted, which includes the Toilet Rooms.
- 3. Prep and finish casework the same as they are now.
- 4. Remove and replace any coat hooks, cabinet pulls, etc., and any other wall mounted items before beginning prep. Patch holes and drywall
  - 5. Most rooms have a single wall color with the exception of the Gymnasium and Cafeteria which may have the 4J white lower and Whisper White upper portions.
