ADDENDUM #1:

YOU ARE HEREBY DIRECTED TO PERFORM THE FOLLOWING WORK AND INCLUDE THE FOLLOWING WORK IN YOUR BID.

- Item #1: The mandatory pre-quote sign in sheet is attached for you reference.
- Item #2: The Quote Date has been revised to October 20, 2015 at 2:00pm – Bidders shall submit their quotations on the attached Quotation Form (Revised).
- Item #3: The existing top rail padding shall be removed, salvaged and reinstalled on the new fencing.
- Item #4: The new backstop location shall match the existing 4' fence location – approximately 4' east from the location currently shown on Sheet A1.1.
- Item #5: Sheet A1.2 – fencing is not required between the heights of +48" above grade to the top of the dugout roof. Contractors shall provide additional horizontal rails as necessary to support the fencing. This condition is consistent for the entire length of the new backstop.
- Item #6: All existing finishes shall be restored to match the existing conditions – including but not limited to concrete slabs, granular fill, turf, irrigation systems, fencing, paint, etc.
