The following item is being issued to the above referenced ISD 16-218. All other specifications, requirements, terms and conditions of this ISD shall remain unchanged.

**1. Correction:**

The first paragraph in Part I, A. Description of Project shall be modified by removing the phrase ‘and the VPN Concentrator’. The modified sentence shall now read: ‘The District has a project to replace the current District Firewalls.’

**2. Clarification of Specification:**

A clarification in the description of the FortiGate 1200D; equal or better has been listed in the attached Revised Part III. Quotation Form. Submissions of Quotations should be made using the Revised form.

**3. Vendor Questions:**

Q: Will the district require the UTM firewall bundle on these appliances?

A: The District wants the firewall bundle.

Q: What type and length of Fortinet hardware support should be quoted? Options include:

- 24 x 7 Support (recommended – changes to firewalls are often made outside of regular business hours)
- 8 x 5 Support
- Length of support contract: 1, 2 or 3 year

A: As defined in Part I, B. 3. All submissions shall include: A. Warranty coverage provided on all equipment purchased. Minimum basic maintenance shall be 1 year from the date of equipment delivery. Additionally Vendor may respond with additional information on maintenance and pricing beyond the minimum requested basic one year maintenance.

Q: Will these firewalls be used in redundancy (active/active, active/passive) – this will make a difference on E-Rate funding

A: The District can accommodate configuring redundancy in either way. Please submit your response with the configuration that qualifies for the maximum E-Rate reimbursement.
