ADDENDUM #1:

YOU ARE HEREBY DIRECTED TO PERFORM THE FOLLOWING WORK AND INCLUDE THE FOLLOWING WORK IN YOUR BID.

- Item #1: See the attached mandatory Sign-In sheet.
- Item #2: On all wood doors: there are no wood infill repairs required.
- Item #3: Where any door is cut (wood or metal): the existing finish shall be touched up with matching door finish (polyurethane or paint) – the entire door is not refinished.
- Item #4: Door #1 – Stage Area: the new ramp shall be set in grout to provide solid, continuous support.
- Item #5: The Owner (District) shall disconnect and reconnect any / all electrified door hardware.
- Item #6: The Owner is not requesting any salvage from this project – all waste shall be disposed by the Contractor.
- Item #7: The Owner will provide a dedicated secure area for the Contractor to stage materials on-site.
- Item #8: All new ramps that do not receive “aprons” at the exposed ends shall be packed with non-shrink grout eliminating all sharp edges.
- Item #9: See the attached photo & sketch demonstrating an acceptable method for providing post mounted door stops and wall stops.
- Item #10: Any additional questions from Contractors shall be received by 5/14/2018 @ 5:00pm.
