The Following is an addition to the Original Project Manual.

Individuals with whom the District contracts with, or any employee, agent, subcontractor or Provider who will have access to District school facilities shall be required to submit a 4J Volunteer Background check and undergo a state and nationwide fingerprinting and criminal history records check, in accordance with the provisions of ORS 326.603 and ORS 326.607. Individuals or Proposer, and not the District, shall be responsible for the fees associated with fingerprinting and the criminal history records check, not to exceed the actual costs (ODE \$59.00 and outside fingerprinting vendor \$12.50). Independent Contractors are asked to complete the Volunteer Background check is received you will pay the District the ODE fees and complete the fingerprint process through Field Print.

The forms attached have the necessary information to complete the Background/Fingerprinting process.


Step 1: Eugene School District 4J Background Check Process:

All independent contractors of the district must first go through the volunteer background check process. This allows you to be cleared to start your job while we wait for the ODE fingerprint process to go through. If you have previously been finger printed for a school district in Oregon and have not moved out of the State please completely fill out both sides of the **green form** attached and return it to the HR/Finance Resource Center and complete the rest of Step 1. We will follow up with next steps if necessary.

Please visit <u>http://www.4j.lane.edu/hr/volunteers/</u> read through the information that is available and place your application. This gives the district the authority to screen your criminal history. PLEASE ALLOW TIME FOR PROCESSING- If you have a criminal history it can take longer to get you through the process.

When selecting a location that you are interested in please only select 4J-INDEPENDENT CONTRACTORS. Please make a note in the comment section of your company name. If you have students at one of our locations you can select their school as well but will be required to take additional steps for your approval, include your student's names when prompted.

Please provide an email address that you check on regular bases as this will be how you are notified of your approval or denial. Should you get a denial you can enter into the appeal process. Please note however while you are going through this process you do not have the necessary clearance to start your job.



When answering the questions regarding any criminal history please include things that you believe to have been expunged. If the district locates charges that were not disclosed you will receive an automatic denial. Should you mark yes on any of the questions please provide a concise explanation as to the circumstances that led to the charges for each one on your record. Located on the back of this form are all crimes that will result in an automatic DENIAL from both 4J School District and ODE.

Once you receive approval please print the email to provide it to Financial Services and move on to Step 2.

Subject individuals who have been convicted of any of the crimes listed in ORS 342.143, (listed below under crimes relating to question 1), or the substantial equivalent of any of those crimes if the conviction occurred in another jurisdiction or in Oregon under a different statutory name or number, shall be refused continued employment or have employment terminated upon notification from the Superintendent of Public Instruction.

Upon entering the front entrance, please check in with the HR/Finance resource center. The ODE processing fee is \$59.00 per background check. We can only accept exact change or checks. Please make checks out to 4J School District.
