April	<ul style="list-style-type: none"> <li>• Evaluate programs and services for the <i>current</i> school year and make suggestions for modifying programs that will be implemented during the 2019-2020 SY.</li> <li>• TITLE IIA:               <ul style="list-style-type: none"> <li>○ Using the <i>Needs Assessment and Program Development Plan for Title IIA</i> form as a guide, consult with officials to identify the needs of students and teachers, discuss services and estimate funding figures, design programs and establish priorities for the 2019-2020 SY.</li> </ul> </li> <li>• TITLE IA:               <ul style="list-style-type: none"> <li>○ Using the <i>Title I Assessment Information to Develop a Program Evaluation Plan/Modifications</i> form, consult with officials to assess the progress of the 2013-2014 Title I program and consider modifications to the plan, if necessary, for the 2019-2020 SY. School officials should complete the <i>year-end student progress</i> column <u>prior</u> to our spring consult.</li> </ul> </li> <li>• Share the consultation timeline for the 2019-2020 SY.</li> <li>• Send schools their 2019-2020 SY Title IA and/or Title IIA Needs Assessment forms               <ul style="list-style-type: none"> <li>○ Title IA: Complete <i>instrument</i> and <i>goals for student achievement</i> sections <u>prior</u> to our August consult</li> <li>○ Title IIA: Complete entire form <u>prior</u> to our May/June consult</li> </ul> </li> </ul>
May/June	<ul style="list-style-type: none"> <li>• Provide preliminary program funding figures to officials for the 2019-2020 SY.</li> <li>• Finalize plans for programs and services (Title I and/or II) and set dates for when they will begin in the <i>next</i> school year.</li> </ul>
August	<ul style="list-style-type: none"> <li>• Share final funding figure updates with school officials.</li> <li>• Title IA Plan for the 2018-2019 SY is due</li> </ul>
