

DISTRICT K-12 COUNSELING SPECIALIST - TOSA

Position Summary

The District Counseling Specialist TOSA is a one-year temporary position. This educator works with teachers and administrators to implement the ASCA Standards and sound social and emotional learning programs, including coaching school-based counselors/teams, and delivers professional development in both small and large groups. Planning, organizing and leading professional development are expected as part of this assignment.

Supervisory Relationship

This position reports to the Curriculum Director within the Instruction Department.

Essential Functions

- 1. Develop, implement and manage program alignment and learning targets across all aspects of school counseling programs.
- 2. Oversee the dissemination of digital curriculum and resources for elementary, middle and high school counselors.
- 3. Train administrators and counselors to employ district-adopted programs with fidelity.
- 4. Assist with effective implementation of the district's Threat Assessment. Suicide Prevention and Mental Health initiatives.
- 5. Assist administrators and counselors in implementation and use of social and emotion instructional programs.
- 6. Support secondary school counseling teams in developing systems that ensure students maintain on-track status throughout their secondary years or are quickly identified if not on-track.
- 7. Conduct and analyze data regarding overall school culture and effectiveness.
- 8. Provide professional development for counselors and administrators on American School Counseling Standards (ASCA), counseling programs, and Naviance.
- 9. Support school-based counselors in the differentiation of district adopted programming.
- 10. Coordinate with Secondary TOSAs to plan and provide cohesive professional development across content areas where appropriate.
- 11. Coordinate testing throughout the year as appropriate and related to district goals and ASCA standards.
- 12. Performs other duties as assigned.

Required Knowledge, Skills and Abilities

- 1. Ability to communicate effectively orally and in writing.
- 2. Strong knowledge of ASCA standards, and a broad background in school-based counseling.
- 3. Experience as a school-based counselor, ideally at multiple levels, in a public school setting.

- Demonstrated track record of successfully serving a broad range of students and utilizing a systems approach to ensuring schools meet the needs of all students and families it serves.
