Annual School Budget Vote and School Board Election

Dear Garrison Community,

We are excited to share the Garrison Union Free School District's proposed budget for the 2024-2025 academic year. After thorough analysis and collaboration between the Board of Education and the administrative team, we developed a budget that reflects our commitment to fiscal responsibility while maintaining essential programs and staffing levels. We are recommending a \$13,369,573 spending plan, which represents a 4.44% tax levy increase that falls within the allowable tax cap limit. This budget supports academic excellence, environmental and sustainability education, the performing arts, athletics, extracurricular activities, and high school choice.

In recent years, we have made significant progress in improving our school's infrastructure. Capital projects such as the installation of an all-electric HVAC system, motion sensor LED lights, water saving plumbing valves, and low maintenance vinyl floors have not only reduced our environmental footprint, but also enhanced the health and wellness of our students and staff. However, there are still remaining facilities issues, such as roofing, masonry, paving, and building envelope projects that need to be addressed.

To ensure the preservation of one of Garrison's most valuable assets, we have developed a multi-year strategy to tackle one school building improvement project annually, avoiding the need for borrowing in the current high-interest rate environment. For example, the 2024-2025 budget allocates \$250,000 for the replacement of the Gymnasium roof. Upon approval by the taxpayers, this project will commence in the upcoming school year. Through persistent advocacy, the District has secured a \$125,000 NYS CREST grant, which will be released upon the project's completion. This grant money will then be applied to offset the cost of future projects.

To close the budget gap, we intend to use \$902,878 from our fund balance reserves. Due to successful lobbying efforts and FEMA COVID-19 reimbursement funding, our unassigned fund balance now exceeds the allowable 4%. Therefore, we are confident in allocating monies from the fund balance to cover the budget shortfall for this fiscal cycle. While we recognize that relying on fund balance is not a sustainable long-term strategy, we believe it is a prudent measure for this year to alleviate the financial burden on our community.

We encourage all community members to participate in the Annual School Budget Vote and Board of Education election scheduled for Tuesday, May 21, 2024, from 7:00 AM to 9:00 PM in the Garrison School Gymnasium. Proposed 4.44% Tax Levy Increase Frequently Asked Questions

IS THE DISTRICT SEEKING AN OVERRIDE THIS YEAR? No.

IS A 4.44% TAX LEVY INCREASE WITHIN NYS'S TAX CAP FORMULA? Yes. The Garrison Union Free School District's proposed tax levy increase is 4.44%, which is the maximum amount allowable under the NYS tax cap formula.

WHAT ARE THE BIGGEST BUDGET DRIVERS FOR THE 2024-25 SCHOOL BUDGET? The significant drivers include a proposed gymnasium roof replacement project, gymnasium floor refinishing, high school tuition expenses due to enrollment, transportation costs, hiring a new elementary teacher for an additional kindergarten section, and various other expenditures. WHAT IS THE YEAR-OVER-YEAR BUDGET INCREASE? The proposed budget represents a 6.4% (or \$804,785) increase in spending from the 2023-24 school year.

HOW DOES OUR TAX RATE COMPARE WITH OTHER SCHOOL DISTRICTS? Per \$1,000 of assessed value, Garrison taxpayers have the second lowest tax rate out of 88 school districts in the Lower Hudson Valley region, which includes Dutchess, Orange, Putnam, Rockland and Westchester counties. Garrison's school tax rates are lower than 90% of the districts in New York State.

WAS GARRISON'S NEW YORK STATE FOUNDATION AID REDUCED? Initially, under Governor Hochul's Executive Budget proposal, Garrison faced a 39.5% decrease in Foundation Aid, amounting to a \$234,036 reduction. However, thanks to strong lobbying efforts and opposition from the Senate and Assembly, Foundation Aid was reinstated in the final NYS budget.

WHY USE FUND BALANCE TO CLOSE THE BUDGET GAP VERSUS AN OVERRIDE? After the approval of the 2023-2024 budget, the District secured special NYS aid through successful lobbying efforts, and received FEMA COVID-19 reimbursement funding. Furthermore, during the 2023-24 school year, the District experienced an unexpected decrease in tuition expenses. These developments have increased our unassigned fund balance beyond the allowable 4%. Therefore, we are confident in allocating \$900,000 from the fund balance to cover the budget shortfall.

ARE THERE ANY PLANS FOR AN OVERRIDE NEXT YEAR? At this time, it seems unlikely that the District will require a Tax Cap override for the 2025-26 school year. Nonetheless, factors such as potential cuts in Foundation Aid, unexpected student placement needs, and ongoing inflationary pressures could potentially negatively impact our budget.

WHAT IS THE BENEFIT OF THE TRANSFER TO CAPITAL FOR FACILITIES IMPROVEMENTS? By including facilities improvement projects into our annual budget, we avoid the need to borrow money in today's high interest rate environment. For instance, if we were to obtain a 15-year bond at 4% for the planned \$250,000 gymnasium roofing project, the District would incur approximately \$40,000 in interest payments over the life of the loan.

CONTRACTS WITH HALDANE CENTRAL SCHOOL DISTRICT AND HIGHLAND FALLS/FT. MONTGOMERY CENTRAL SCHOOL DISTRICT. WHY DO THESE SAME PROPOSITIONS APPEAR ON THE BALLOT AGAIN TWO YEARS LATER? Our aim in proposing extensions of the existing five-year contracts through June 2029 is to secure tuition rate increases tied to CPI or 2%, whichever is less for each cohort of Garrison students from grade 9 until their high school graduation.


WHAT HAPPENS IF VOTERS DO NOT APPROVE THE BUDGET ON MAY 21ST? The Board of Education may propose the same or a revised version of the budget for a re-vote on June 18, 2024. They also have the option to prepare and adopt a contingency budget without going back to the voters.

WHAT DOES A CONTINGENCY BUDGET MEAN? Under education law, if a school district adopts a contingency budget, the tax levy increase may not exceed the previous year's levy. To comply with this requirement, the Garrison Board of Education would need to reduce \$649,143 from its proposed budget with cuts to programs Additionally, the District would need to eliminate the gymnasium roof replacement project from the budget, which would cause the District to lose \$125,000 in NYS CREST funding. A contingency budget requires the Board to list all potential cuts to staff and programs as well.

MUCH NEEDED FACILITIES IMPROVEMENTS

The 2024-2025 budget provides funding for building maintenance projects that include refinishing the gymnasium floor and replacing the gym roof without incurring high interest fees through borrowing.





VOTER QUALIFICATIONS

- Must be a United States Citizen

Understanding The Propositions

➤ Voter approval of **Proposition #1 - The Budget**, authorizes the District to meet the estimated expenditures for the 2024-2025 school year by maintaining all current programming as well as estimated year to year cost increases noted in the budget presentations. If approved by a simple majority of the voters, this proposed budget includes an allowable tax cap limit increase of 4.44% based on the formula for Garrison.

Our aim in proposing extensions of the existing five-year contracts through June 2029 is to secure tuition rate increases tied to CPI or 2%, whichever is less for each cohort of Garrison students from grade 9 until their high school graduation.

- ➤ Voter approval of Proposition #2 Term of Instruction Contract with Haldane Central School District, authorizes Garrison to legally enter into a multi-year contract with the Haldane Central School District for the education of Garrison students in grades 9-12.
- Voter approval of Proposition #3 Term of Instruction Contract with Highland Falls/Ft. Montgomery Central School District, authorizes Garrison to legally enter into a multi-year contract with the Highland Falls/Ft. Montgomery Central School District for the education of Garrison students in grades 9-12.
- Voter approval of Proposition #4 Voter Registration, allows the district to register voters continuously throughout the school year rather than only on two specific dates.
