# 2021-22 District Budget Priorities

A community vote on Germantown CSD's 2021-22 budget will take place Tuesday, May 18 from noon - 9 p.m. at the Kellner Community Activities Center at which time the polls will be opened to vote by voting machine. The 2021-22 school budget totals \$16,331,182 and requires a 0.82% tax levy increase, which is within New York State's Property Tax Cap.

This year's proposed budget will focus on bringing more elective opportunities into the district for students to develop a wider skillset and explore a larger variety of career pathways as well as bring staff back into our district whose positions were cut due to the COVID-19 pandemic.

"It's our goal to ensure our students graduate from Germantown Central Schools college- and career-ready," said District Superintendent Benjamin Bragg. "Providing more elective opportunities to our students will allow us to do just that. Granting students the chance to experience distinct curriculums will also help them make an informed decision for their career field or college major, which will save parents money in the long run."

Germantown Central School District is committed to bringing staff back into its building who were cut due to the COVID-19 pandemic should the budget vote pass. Bringing back staff would include the return of the school's Spanish program.

The community will also vote on two open seats on the Board of Education. One seat will be a full four-year term, and one seat will be a three-plus year term.





If the proposed 21-22 budget were defeated by the voters in May, the Board of Education may hold a second budget vote in June or immediately adopt a contingency budget. Contingency would require the school district to eliminate, a transfer to the capital fund in the amount of \$100,000 for a planned construction project. In addition, most 21-22 proposed equipment purchases in all three parts of the budget, totaling \$83,898, would have to be eliminated. The administrative portion of the budget would also need to be reduced by another \$3,800. The required reductions total \$187,698.

### **Program, Administrative and Capital Budget Components**

When portraying the proposed budget in three component parts (Administrative, Program and Capital) school districts are required to allocate a reasonable share of employee fringe benefits to each of the three components. In the 2020-21 proposed budget, all fringe benefits were allocated incorrectly to the program component. Thus, the component totals for 2020-21 were recalculated and do not match the numbers reported in the 2020-21 Budget Newsletter.

### **BOARD OF EDUCATION ELECTION**

Voters will elect candidates to fill two (2) open seats on the Board of Education. One seat is a four (4) year term, and the other seat is a three-plus (3+) year term. The candidate with the highest number of votes will fill the full four (4) year term. The following candidate will be listed on the ballot: Linda Anderson.

#### **LINDA ANDERSON**

When and where is the vote?

Who is eligible to vote? Anyone who is a U.S. citizen, 18 years of age or older and is a resident of the Germantown Central School District for a period of 30 days or more prior to the day of the vote or is registered to vote with either the School District or the Columbia County Board of Elections.

How can I vote by absentee ballot? An eligible voter who is unable to go to the polls on May 18 can cast their vote by absentee ballot. Applications for absentee ballots may be obtained at the District Office. If you would like your ballot to be mailed to you, applications must be received by District Clerk Elizabeth Liberti at least seven days prior to the vote. Applications must be received by the District Clerk by May 17 if the ballot will be picked up personally by the voter.

Completed absentee ballots must be received at the office of the District Clerk no later than 5 p.m. on May 18. Those who do not wish to vote in person due to COVID-19 may request an application for an absentee ballot.
